BE IT ORDAINED by the Effingham County Board of Commissioners in regular meeting assembled and pursuant to lawful authority thereof:

The following shall be revised in Part II, Appendix C, Article VII – Planning Board, Section 7.1.2 Meetings:

Meetings of the planning board shall be held on the ~~third Monday~~ **second Tuesday** of each month. The chairman, or in his absence, the vice-chairman, may administer oaths and compel the attendance of witnesses by subpoena. The planning board shall keep minutes of its proceedings, show the vote of each member upon each question, or if absent or failing to vote, indicate such fact, and shall keep records of its examinations and other official actions, all of which shall be immediately filed in the office of the board and shall be a public record.

All ordinances or parts of ordinances in conflict herewith are hereby repealed.
