

**Amendment No. 1 to the
EMS Services Agreement
Executed October 4, 2023
between
Board of Commissioners of Effingham County
and
Buccaneer Region, Sports Car Club of America, Inc.**

THIS AMENDMENT NO. 1 (the "Amendment") is entered into this ____ day of _____, 2026 by and between the **County of Effingham** ("County") with offices at 804 S Laurel Street, Springfield, GA 31329 and **Buccaneer Region, Sports Car Club of America, Inc. d/b/a Roebling Raceway** "Roebling Raceway" with offices at 1135 Roebling Road, Bloomingdale, GA 31302.

WHEREAS, the COUNTY and ROEBLING RACEWAY entered into an EMS Services Agreement effective October 4th, 2023 for the provision of emergency medical services at Roebling Raceway; and

WHEREAS, the Agreement provides that the parties may agree to renew the Agreement annually, subject to increases in payment and any other terms that may need to be revised; and

WHEREAS, EMS services have continued under the terms of the Agreement, and the parties desire to formally document the continued term of the Agreement; and

WHEREAS, the parties desire to amend the payment provisions of the Agreement effective January 1, 2027.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises in the Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below.

1. **Continued Term:** The parties acknowledge and agree that EMS services have continued under the terms of the Agreement. The parties hereby confirm and document the continued term of the Agreement through December 31, 2026, unless earlier terminated in accordance with the Agreement.
2. **Renewal Term:** This Amendment allows for the Agreement to renew for a two-year term beginning January 1, 2027 and ending December 31, 2028, unless earlier terminated in accordance with the Agreement.
3. **Fee:** Effective January 1, 2027, the payment provisions of the Agreement are amended to provide that ROEBLING RACEWAY shall pay the COUNTY **\$825.00 per day, per ambulance**, with a one-day minimum. This daily rate includes one ambulance and required EMS staffing for the day.
4. Except as specifically set forth herein, all other terms and provisions of the Agreement shall remain unaffected by this Amendment and continue in full force and effect.
