Corporate Wellness Contract MOU

Effingham County has an agreement with the YMCA of Coastal Georgia, Inc. whereby the YMCA will waive the Joiner's Fee and will receive 15% off towards new YMCA of Coastal Georgia enrollments.

Effingham County terms of agreement are as follows:

- YMCA of Coastal Georgia Joiner's Fees associated with the membership rates are waived.
- Employees will receive 15% off monthly membership rates.
- Membership enrollments, changes, and cancellation can be done at the branch.
- While we have no contracts, we do request a 30 day notice for cancellations and all correspondence will be sent to Lynsey Clements lynsey.clements@ymcaofcoastalga.org
- Billing questions to Misty Jenkins misty.jenkins@ymcaofcoastalga.org.
- Any changes in employees' membership will be done within 48 hours.
- All memberships include 24-hour access at participating branches.

Additional Family Workplace Wellness Benefits:

- Member rate for summer camp for employees' families
- Member rate for Swimming lessons for employees' families
- Member discount on all youth sports including gymnastics.
- Member discount on YBASE before and after school rates
- Employee Family Field days available Free to the organization
- Employee Fitness Challenges available
- Safety Around Water classes can be scheduled for employees' families.

Based on the needs, the Y can provide the following:

1. YMCA of Coastal Georgia will attend on-site Open Enrollments & Health Fairs
2. Employers will receive corporate rates for group events/activities at YMCA of Coastal Georgia branches.
3. Fitness Challenges for employees are available seasonally for an additional fee of \$300.00 per challenge to the company. Fitness Challenges are 6-8 weeks and include all before and after measurements and tracking of success.
4. Lunch and Learn seminars for employees are available quarterly for an additional fee of \$200.00 per seminar to the company. Company chooses the topics of discussion.
5. On site Fitness Classes can be arranged for an additional cost of \$50 per class

Term:

A. The term of this Agreement shall commence as of 3-11-2025 and shall expire 3-11-2026. This Agreement shall automatically renew for each subsequent year unless thirty (30) days prior written notice is given by either party. This Agreement may be reviewed by YMCA of Coastal Georgia each year, and YMCA shall provide written notice of any proposed changes to the YMCA Corporate Membership program ("Workplace Wellness") for a renewal year no later than sixty (60) days prior to the date such renewal year would begin. The YMCA of Coastal Georgia may also increase membership rates a maximum of one (1) time during each renewal year, and the YMCA shall provide written notice of any changes to the rates no later than forty-five (45) days prior to the date such rate change would begin. **Effingham County** shall have the right to terminate this Agreement by giving fifteen (15) days written notice following such notice of a rate increase.
