WHEREAS, THE COUNTY and Atlas Technical Consultants, LLC entered into a Contract dated July 26th, 2024 for Indefinite Delivery Professional A&E Services (as amended, the "Contract"); and

WHEREAS, the parties desire to amend the provisions of the Contract; and

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises in the Contract, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below.

1. Term: The contract shall renew for a period of one (1) year, expiring June 30, 2026.
2. Fee: The vendor's rates shall be amended as set forth in this Amendment No. 1. The revised rates shall apply only to new projects authorized after full execution of this Amendment No. 1. The amended rate schedule is attached hereto as Attachment A and incorporated herein by reference.
3. Except as specifically set forth herein, all other terms and provisions of the Contract shall remain unaffected by this Amendment and continue in full force and effect.
