# **Summary Recommendation:**

Staff recommends approval of the resolution to adopt the 2025 fire fees.

#### **Executive Summary/Background:**

Each year, the Board of Commissioners approves a resolution to set the fire fees. This fee structure is based upon the current and anticipated costs to provide fire services for the unincorporated residents of the County, as well as residents in Springfield and Guyton.

#### 1. Fire fees for the prior year were set at:

Residential (per dwelling unit)	\$ 150.00 per year plus \$0.03 per sq. ft.
Multi-Family (per dwelling unit)	\$ 150.00 per year plus \$0.03 per sq. ft.
Commercial (per structure)	\$ 400.00 per year plus \$0.07 per sq. ft.
Industrial (per structure)	\$ 550.00 per year plus \$0.07 per sq. ft.
Solar Farm	\$ 50.00 per acre
Vacant Parcel	\$ 0.12 per Acre
(with no primary structure)	

#### 2. Staff recommends the following fire fee for 2025:

Residential (per dwelling unit)	\$ 165.00 per year plus \$0.05 per sq. ft.
Multi-Family (per dwelling unit)	\$ 165.00 per year plus \$0.05 per sq. ft.
Commercial (per structure)	\$ 450.00 per year plus \$0.09 per sq. ft.
Industrial (per structure)	\$ 600.00 per year plus \$0.09 per sq. ft.
Solar Farm	\$ 55.00 per acre
Vacant Parcel	\$ 0.12 per Acre
(with no primary structure)

10,000 – 99,999 lbs.	\$ 1,375.00

For a 2,000 square foot home the 2024 fee would be \$210.00 while the proposed 2025 fee would be \$265.00.

The following are EXEMPT from provisions and requirements of the Haz-Mat Fee:

1. Persons and facilities whose only hazardous substance subject to the reporting requirements cited in compliance with 312 Superfund amendments and Reauthorization Act (SARA III) are petroleum products (e.g. gasoline, diesel or oil) held only for retail sale to the general public.

2. Units, divisions, agencies, authorities, commissions of local, state or federal government.

3. A critical facility which stores petroleum products (e.g. gasoline, diesel or oil) for use during an emergency. Only petroleum products used for emergency operations will be considered for exemption.

4. A business which is regulated by the Georgia Public Safety Commission.
