Summary Recommendation

Staff finds that the request meets the intent of the Assemblage Permit requirements by providing a controlled environment for community engagement. Staff recommends approval of the Assemblage Permit for the Royal Oak Plantation Subdivision to host the annual Trick-or-Treat event on October 31, 2025.

Executive Summary/Background

The applicant has requested approval for an Assemblage Permit to host the annual Trickor Treat Event within the Royal Oak Plantation Subdivision, creating a community-wide, family-friendly Halloween experience in a controlled setting. Traffic and Safety Measures are as follows:

- 1. The subdivision will be closed to through traffic during the event.
- 2. A Sheriff's Deputy will be stationed at the subdivision entrance to manage traffic and ensure resident access.
- 3. Residents will be permitted to enter and exit under the deputy's direction.
- 4. Non-residents will park along Hwy 17 and walk into the subdivision.
