

# **Executive Summary**

It aligns with key strategies and approved uses outlined in Exhibit E of the **Opioid Use Settlement Fund Agreement**, making it eligible for funding through the Opioid Settlement Funds (OSF) allocated to states and localities.

Through OSF, first responders - including both sworn and non-sworn officers - can take this course with **full funding support**. Additionally, officers may be eligible to receive paid overtime for completing the training. This means your Police Department can access all the program's benefits without incurring any costs against the department's budget.



# **Settlement Overview**

# **Escalation of Opioid Crisis in the United States**

The opioid crises has quickly become one of our number one drug issue impacting us today. Over **101,000 opioid overdose deaths** are estimated for 2024. Fentanyl remains a primary driver of these fatalities, posing a significant threat to public health.

- Opioid-related deaths now surpass both traffic fatalities and homicides, highlighting the urgency of addressing this epidemic.
- Opioid emergencies account for 20-25% of 911 calls.
- Communities across all demographics are impacted, underscoring the importance of effective interventions.



Police officers are increasingly called to front lines to manage these situations, making it critical to ensure they're equipped with the right tools and strategies to safely and effectively respond.

#### The National Opioid Settlement Agreement

- Settlements resulted from litigation against the major opioid manufacturers, distributors, and retailers.
- Nearly \$50 billion to help combat opioid crisis.
- Includes law enforcement officer training, often first responders in opioid emergencies.
- Police departments can use funds for specialized training programs emphasizing **de-escalation techniques**, **crisis intervention strategies**, and the proper **administration of naloxone**.

The overall goal is to shift from punitive measures toward a more health-centered approach, aligning law enforcement with broader public health initiatives.

# **Exhibit E - List of Opioid Remediation Uses**

#### Schedule B, Section D, 1.4:

1.4 **Officer prevention strategies**, such as the Law Enforcement Assisted Diversion ("LEAD") model;

#### Schedule B, Section I:

- 1. **Education of law enforcement** or other first responders regarding **appropriate practices** and precautions when dealing with fentanyl or other drugs.
- 2. Provision of **wellness and support services** for first responders and others who experience secondary trauma associated with opioid-related emergency events.

#### How settlement funds can be spent

States are set to receive a **significant portion of the national opioid settlement funds**, which can be strategically allocated to address the opioid crisis.


One key focus area is **police training**, equipping law enforcement officers with the skills and knowledge necessary to handle opioid-related crises effectively.

Training should emphasize **de-escalation techniques**, **Naloxone administration**, **harm reduction strategies**, and **collaboration and referral strategies** to connect individuals with treatment resources.
