Dear Mr. Callanan:

The above referenced project was Let May 2021 and awarded July 9, 2021. As project Sponsor, this letter requests Effingham County provide additional funding for the project. GDOT has been made aware that a pay item was left out of the plan and contract quantities. It was agreed upon that the Georgia Department of Transportation (GDOT) would fund the project with \$38,245,284.05 in construction funds, with the remaining construction funding coming from Effingham County. The pay item not covered in the original plan quantities and construction contract is listed below. The Department requests that Effingham County provide additional funds in the amount of \$78,501.12 to cover the cost and resolve the Notice of Potential Claim (NOPC-1).

On March 6, 2023, the Department directed Balfour Beatty to cease all work activities needed to perform the installation of the 8X4 5 Barrell culvert at STA 247+76 due to concerns related to existing water flow direction as well as incorrect invert elevations on said culvert. As of the morning of March 6th, the department has been reviewing the effects in hydrology due to incorrect information in the projects plan sheets.

Attached to this document is a letter from Williams Contracting Company notifying Balfour Beatty of this delay. This delay not only impacts Williams Contracting Company but also Balfour Beatty in regards to direct daily cost, equipment, overhead, per-diem, burden, and schedule.

Since our firm is at a stopping point since Friday, per the GDOT direction, we will be sending a breakdown of daily costs incurred, including direct labor, equipment, overhead, per-diem, burden, G&A expense, etc., as a direct result of this design issue that is preventing our company to actively working on this project.

Mr. Mydell,

After further analyzation of the 8x4 5 Barrell Culvert on the above referenced project, it has come to our attention that the flow of water depicted in the plans is incorrect. Based on field conditions, the existing stream is flowing the opposite direction as noted in the plans. The elevations provided to BBII show the flow line of the culvert being at 55.23 and 55.38 from left to right. Based on survey points, the existing stream elevations sit at 54.17 and 54.09 from left to right.

Please see the attached supporting documentation showing the elevations in the field vs the plan elevations along with the field depiction of the current flow of water at this location.

Please advise Balfour Beatty of GDOTs intention for the construction of the above-mentioned culvert.
