

ADDENDUM TO SOFTWARE SERVICES AGREEMENT
BETWEEN THE EFFINGHAM COUNTY BOARD OF ASSESSOR'S OFFICE
AND
THE EXEMPTION PROJECT, INC. (DBA TrueRoll)
FOR CHANGE IN SERVICES

This Addendum executed on July 1st, 2025, the Effective Date, by and between the THE EFFINGHAM COUNTY BOARD OF ASSESSOR'S OFFICE hereinafter the "Customer" and THE EXEMPTION PROJECT, INC. (DBA TrueRoll) hereinafter the "Company", collectively "The Parties", is an Addendum to the original agreement, named TRUEROLL SOFTWARE SERVICES AGREEMENT, which was executed by the Parties on April 18, 2023, for the purpose of changing the agreement term, contracted services and or annual fees.

The Parties mutually understand and all of the terms, conditions, and provisions in the original contract and Proposal remain in full force and effect and are unchanged except as expressly amended hereby.

1) CHANGE IN CONTRACT TERM:

2) CHANGE IN SERVICES:

New Services after Addendum

The following listed services shall be the new services including the currently contracted services and made effective as described below:

	New Service: Application Vetter
INTAKE: New Homestead Exemption Applications sent to Company	<ul style="list-style-type: none">• Online homestead applications - Originating from an existing Customer, CAMA, or 3rd party provided online application form*• Paper applications - Scanned/pdf files uploaded via a secure online portal provided by the Company.**
OUTPUT: Report results delivered to the Customer	<ul style="list-style-type: none">• Application Vetter Report results and workflow features provided by the Company are accessed via a web-based application provided by Company and currently used by Customer for currently contracted services.

*Online Applications: The secure transfer of new application data from an online application form to the Company's system requires collaboration with the Customer's form provider. The Company will make its best efforts to work with the Customer's online form provider to automate the secure intake of all new homestead application data received via the online form. However, the Company cannot guarantee the

performance or timeliness of any third-party vendor (CAMA or others) and will not be responsible for any fees or programming costs charged by the form provider to the Customer, nor for delays or defects in workmanship by third-party vendors in establishing and maintaining a secure connection for the purpose of providing application vetting services.

****Paper Applications:** Customer shall make best efforts to provide reasonably high quality pdf scanned applications with supporting documents to the Company on a mutually agreeable schedule. Company expects an OCR fidelity rate of at least 75% for all high-quality scanned paper applications.

3) CHANGE IN FEES:

Fees for services shall be updated

from: \$10,900 per year (billed annually) as currently contracted

to: \$19,350 per year (increase of \$8,450 annually)

4) CHANGE IN ANNUAL INVOICE SCHEDULE OR AMOUNT:

A Pro-Rata Invoice for the new services added shall be calculated and delivered to Customer as of the effective date of this Addendum.
