AN ORDINANCE TO AMEND THE OFFICIAL ZONING MAP OF EFFINGHAM COUNTY, GEORGIA

BE IT ORDAINED by the **Board of Commissioners of Effingham County, Georgia (hereinafter referred to as the “Board of Commissioners”)**, in regular meeting assembled and pursuant to the authority granted by the laws of the State of Georgia and the Effingham County Zoning Ordinance, that the Official Zoning Map of Effingham County be amended as follows:

Application

An application was submitted by Timothy Peavy requesting the rezoning of approximately 5.06 ± acres, identified as Tax Parcel 233A-1, located on GA Hwy 17 North in Commission District 3, from AR-1 (Agricultural Residential; 5-acre minimum lot size) to AR-3 (Agricultural Residential; 2.5 + acres) to allow for permitted uses in AR-3.

Public Hearings and Notice

Notice of the required public hearings was published in the **Effingham County Herald**, the official legal organ of Effingham County, in accordance with the **Georgia Zoning Procedures Law (O.C.G.A. §36-66-1 et seq.)**.

A public hearing was conducted **on June 9, 2026**, before the **Effingham County Planning Board (hereinafter referred to as “Planning Board”)**, with notice published in the Effingham County Herald on **May 15, 2026**.

A public hearing was conducted on **July 21, 2026**, before the Board of Commissioners, with notice published in the Effingham County Herald on **July 1, 2026**.

Findings of Fact

The Board of Commissioners makes the following findings regarding this zoning map amendment:

1. The applicant requested the rezoning of approximately 5.06 ± acres identified as Tax Parcel 233A-1, located in Commission District 3.
2. Notice of the required public hearings was provided in accordance with the **Georgia Zoning Procedures Law**.
3. Public hearings were conducted before both the **Planning Board** and the **Board of Commissioners**.
4. The Board of Commissioners reviewed the application, staff report, Planning Board recommendation, and all information presented during the public hearings.
5. The Future Land Use Map designates the property as Agricultural Residential.
6. The Board of Commissioners finds that the requested AR-3 zoning classification is generally consistent with the Agricultural Residential Future Land Use designation and the AR-3 classification.

Zoning Map Amendment

The Board of Commissioners hereby approves the rezoning of approximately 5.06± acres, Tax Parcel 233A-1, from AR-1 (Agricultural Residential; 5-acre minimum lot size) to AR-3 (Agricultural Residential; 2.5 + acres), thereby amending the Official Zoning Map of Effingham County, Georgia.

Repealer

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Effective Date

This ordinance shall become effective immediately upon adoption by the Board of Commissioners.
