 - Ensures comprehensive IT system readiness for building operations.

- 2. McWright CO 11 Mill and Repave Parking Lot
 - Scope of Work:
 - o Milling and repaving of approximately 6,225 square yards of the parking lot.
 - Restriping all parking spaces to enhance usability and compliance.
