Summary Recommendation: Staff requests the Board to ratify and approve Change Order #5 for McWright, LLC for the Administrative Building Construction

Executive Summary/Background:

Change Order 5 pertains to a request by the owner to revise the scope of work regarding the glass wall in the lobby area of the Effingham County Administration Complex.

Change Order History:

- 1. Change Order 1
 - 1. McWright CO 1 Carriers for wall-hung sinks (8 locations): \$2,857.48
- 2. Change Order 2
 - 1. McWright CO 2 VE Bath Accessories change to standard mirror, soap, paper towel dispenser at all locations: Credit \$12,076.87
- 3. Change Order 3
 - 1. McWright CO 3 Exterior Building Mounted Sign Allowance: Credit \$4,224.11
 - 2. McWright CO 4 Replacement Chandeliers for Lobby: Declined \$0.00
- 4. Change Order 4
 - 1. McWright CO 5 Additional Data Locations: \$10,879.00
 - 2. McWright CO 6 Surge Protection: \$1,646.00
 - 3. McWright CO 7 ADA Parking Lot Changes: \$3,850.00
 - 4. McWright CO 8 Add Door to First Floor Corridor: Declined \$0.00

Original Contract Sum: \$3,317,000.00 Total Addition from Change Orders so Far: \$2,931.50 Updated Contract Sum: \$3,319,931.50

This Change Order 5:

McWright CO 9 – Change Glass Wall in Lobby: **\$0.00**

The specific changes include:

- Credit for glass subcontractor deductions: (\$5,340.00)
 - Deduct to remove aluminum sash: (\$1,940.00)
 - Deduct to remove 1/2" heavy glass wall: (\$3,400.00)
- Additional work costs to Frame and Drywall: **\$5,340.00**

- Demo and patching trim at columns: \$590.00
- Framing, insulation, and drywall installation: \$3,500.00
- Wall painting: \$250.00
- Electrical and data outlet installation: \$1,000.00

This change results in a **net-zero price adjustment**, with no additional cost or time extension required.
