Dear Jonathan,

Moffatt & Nichol is pleased to provide our proposed Work Schedule and Fee Proposal for providing professional engineering services for the Sandhill Road at Blue Jay Road Intersection Improvements for Effingham County.

A. Scope of Services:

The proposed Scope of Services for the above intersection improvements are as provided by Effingham County to Moffatt and Nichol (M&N) on January 15, 2025. In summary M&N will provide surveying, design and permitting for the Sand Hill Road at Blue Jay Road as detailed in the current Effingham County Transportation Master Plan. The proposed project will upgrade the existing roadway from a 4-Way Stop controlled intersection to a Single Lanes Roundabout.

M&N will provide the County the following services to deliver the locally funded design improvements:

- Concept validation
- Survey database preparation
- Preliminary design plans
- Right-of-way plans
- Final design plans
- Permitting
- Bid assistance
- Construction assistance (as needed)

The proposed scope excludes activities that are not anticipated to be required in successful project delivery. These items are as follows:

- FEMA Permitting/Floodplain Analysis
- Geotechnical Investigations and Engineering (standard Effingham County soils characteristics will be utilized in pavement and slope designs)
- Permitting for impacts of state waters and/or wetlands to include 4(f) permitting
- Georgia Department of Transportation approvals, including ICE documentation

- SUE level A or B (SUE level C will be utilized to determine potential conflicts and relocations)
- Right of Way Acquisition

B. Work Schedule:

Moffatt & Nichol will start the design and coordination upon receipt of Notice to Proceed which shall provide an effective date for the start of consultant services. The Scope of Work is anticipated to be completed in 8 months from Notice to Proceed, to submittal of final design plans and bidding documents. It is anticipated that M&N will provide project submittals at milestones for County reviews and the reviews will be conducted expeditiously.

C. Compensation:

Moffatt & Nichol proposes a lump sum budget for the Professional Services as follows:

Task 2- Concept Validation	\$23,740
Task 3- Database Preparation	\$29,798
Task 4- Preliminary Design	\$52,478
Task 5- Right-of-Way Plans	\$15,076
Task 6- Final Design	\$36,602
Task 7- Permitting	\$12,096
Task 8- Bid Assistance & Construction Services (as needed)	\$10,000
Total Engineering Budget:	\$197,422
