

**AMENDMENT TO THE INTERGOVERNMENTAL AGREEMENT FOR THE
JUVENILE COURT IN THE OGEECHEE JUDICIAL CIRCUIT**

Section 2.1.2 of the Intergovernmental Agreement for the Juvenile Court in the Ogeechee Judicial Circuit, dated August 20, 2019, states that “any increase in expenses will need to be requested by the juvenile court judges and approved by the Counties.”

Pursuant to the aforementioned agreement, by signing below, the Counties agree to pay up to the stated amounts for the following expenses of the Juvenile Court for FY 2025.
