25-0879	Found Property	While on patrol, an EPD Officer located a broken phone in the roadway. The owner was identified and contacted to come pick up their property. As the owner did not, the phone was booked into the EPD property room.
25-1030	Warrant Arrest	EPD Officers placed a subject in custody who had an active warrant for their arrest for domestic violence charges out of our agency. The subject was transported to the Elbert County Jail and booked.
25-1034	Found Property	EPD located machine equipment on the side of the road. The property was taken back to EPD, and the owner was contacted. Once the owner arrived at EPD, the property was released to them.

		forwarded to the Elbert County Sheriff's Office for further investigation. The Elbert County Department of Human Services was notified.
25-1045	Domestic Violence	EPD responded to a reported physical domestic violence call. After investigation, it was determined that no crime had occurred.
25-0963	Alcohol Violations	EPD contacted a motorist who had an open container in their vehicle. While the party was not intoxicated, they were issued a municipal summons for having an open contained of alcohol in the vehicle.

25-0884	Assist to Other Agency	EPD responded with the Elizabeth Fire Rescue, Douglas County Bomb Squad, and the Elizabeth School District to a local school. The team safely disposed of unused chemicals without incident.
25-1161	Warrant Arrest	An EPD Officer contacted several parties who were carelessly driving in a parking lot. Upon clearing the parties, it was discovered one of them had a warrant for their arrest. The subject was arrested on the warrant, transported to the Elbert County Jail, and booked.
25-1153	Structure Fire	EPD responded with Elizabeth Fire Rescue (EFR) to an active residential structure fire. The residence was evacuated, and there were no injuries. EFR is conducting their investigation as to the source of the fire.

25-1201	Harassment	EPD received a report of harassment. After investigation, it was determined that the suspects statements are protected under the 1 st amendment, and no crime had occurred.
25-1205	Drug Violation	EPD responded to a local school on a report of a juvenile huffing acetone. The student was identified and issued a municipal summons for a criminal offense.
25-1209	Suicidal Subject	EPD responded to a local school on report of a juvenile who had expressed suicidal ideations. Centennial Mental Health and School Counseling staff evaluated the juvenile. The juvenile voluntarily requested to be transported to a mental health facility. EPD transported and released the juvenile without incident.
25-1225	Assist to Aurora Police	EPD responded to a local school on a reported child abuse. Upon preliminary investigation, it was determined the alleged incident occurred outside of EPD's jurisdiction. The case was forwarded to the Aurora Police Department for further investigation.
