| 24-3773 | Mental Health Hold | EPD responded to a suicidal party. The party had utilized numerous ways to inflict self-harm. EPD placed the party into protective custody and transported them to a local hospital on an Emergency Mental Health Hold. |
| 24-3799 | Domestic Violence | EPD responded to a reported verbal domestic violence. After investigation, it was determined that no crime had occurred. |
| 24-1638 | Municipal Ordinance Violation | EPD Community Services was investigating a property in Town for numerous violations of the Town Code. After several attempts to contact the owner who was nonresponsive to requests to clean the property up, the case was forwarded to the Patrol Division. An arrest warrant was drafted and signed. |
