25-2315	School Threat	EPD received information regarding an alleged school threat. After an extensive investigation, it was determined that the threat was uncredible, and no crime had occurred.
24-4382	Sex Offense	EPD closed a case regarding an alleged sex offense. After an investigation which included numerous search warrants, there was insufficient probable cause to support criminal charges.
25-2439	Animal Complaint	EPD responded to a located dog. The dog was taken to the kennel.
25-2374	Harassment	EPD responded to a local school on report of harassment. After investigation, there was insufficient probable cause to support criminal charges. The case was turned over to the school for administrative discipline.
25-2378	Harassment	EPD responded to a local school on a report of harassment. After investigation, probable cause existed to support criminal charges. The defendant was issued a summons for a criminal offense.
25-2525	Child Abuse	EPD received a report of a cold child abuse. Due to the allegations being serious, forensic interviews were completed. Probable cause was found for criminal charges. The suspect was contacted and arrested. They were booked into the Elbert County jail.
25-2486	Assault & Child Abuse	EPD Officers responded to a local park on a reported assault. After investigation, there was probable cause to existed to support criminal charges. The suspect was arrested and booked into the Elbert County jail.
