SUMMARY

On March 26, 2025, the Dads of Elbert County applied for a Special Event Liquor License for the 5th Annual Meat In Event. Posting has been provided at 366 Grant Street.

Justin Hundley will be the event manager for the Meat In Event. Both Mr. Hundley and Mr. Decker will be present at the Board meeting to answer any questions the Board has.

The map that is included depicts where the licensed area is located and the general mapping for the event. The event will be expanded to include a closure of Grant Street running east to west from Banner Street to Garland Street.

The Elizabeth Police Department does not have any issues that would affect the approval of this license application.


STAFF RECOMMENDATION


