SUMMARY

On April 1, 2025, the Elizabeth Brewing Company (EBC) provided the clerk with 9 Festival Permit Applications and a Security Control plan. A Festival Permit is overseen by the State of Colorado Liquor Enforcement Division. The Town Board is signing off on the permit stating that they agree with the Security and Control plan as well as recognizing that they have approved the security plan, and have examined the premises, know of the character of the Elizabeth Brewing Company.

Obtaining a Festival Permit will give EBC the versatility to provide other alcohol vendors if they choose to. A Festival Permit removes the liability and responsibility of the town carrying a special event permit. This is a positive move in growing and adjusting the Friday Night Markets for now and in the future.

Tony Briggs is here tonight to answer any questions you may have on the Festival Permit or the Security Control Plan.



Security and Control Plan

For Alcohol Beverage Service at The Elizabeth Friday Night Market

Prepared for: The Elizabeth Brewing Company

Date: April 01, 2025

This Security and Control Plan is provided to and agreed upon by The Elizabeth Brewing Company, the participating licensee for The Elizabeth Friday Night Market held from June 20th through August 15th, 2025, at Running Creek Park, 500 E Kiowa Ave, Elizabeth, CO 80107. The plan outlines the procedures and measures to ensure the safe, legal, and responsible service, storage, and management of alcohol beverages during the event.

1. Hours of Service of Alcohol Beverages

Alcohol beverages will be served only during the following designated hours:

• **Start Time:** 4:00 PM

• End Time: 9:00 PM

Service will cease promptly at 9:00 PM each event night (Fridays from June 20th through August 15th, 2025), with no exceptions, and all alcohol sales and consumption will comply with applicable local and state laws.

2. Entries and Exits

- Controlled Access Points: The market will have two pedestrian entrances located at the Northeast corner and Southwest corner of Running Creek Park. Each entrance will be staffed by TIPS (Training for Intervention Procedures)-trained individuals who will:
 - o Check identification to verify attendees are 21+ for alcohol consumption.
 - o Issue wristbands to identify individuals of legal drinking age.
 - Inspect coolers, bags, strollers, and similar items for prohibited items, including outside alcohol.

• **Exit Monitoring:** TIPS-trained staff will monitor exits to prevent alcohol from being removed from the premises and to ensure the safety of departing attendees.

3. Alcohol Storage and Security

- **Setup Phase:** Alcohol will be transported to Running Creek Park by 2:00 PM on each event day in a lockable trailer (or similar vehicle) and remain under the supervision of event staff. The trailer will be secured with padlocks, and only event staff will have access to the alcohol.
- **During the Market:** Alcohol will be stored in locked coolers or behind a staffed bar area and dispensed only by TIPS-certified event staff. Any excess inventory will remain in the lockable trailer, inaccessible to the public, and under staff supervision.
- Post-Market: After each market night concludes, all remaining alcohol will be inventoried, secured in the lockable trailer, and removed from Running Creek Park no later than 11:59 PM. It will be returned to its point of origin for secure storage by The Elizabeth Brewing Company.

4. Handling Visibly Intoxicated Parties

• **Training:** All event staff dispensing alcohol and monitoring the licensed area will be TIPS-certified and trained to recognize signs of visible intoxication (e.g., slurred speech, unsteady movement, aggressive behavior).

• Procedure:

- If an individual appears visibly intoxicated, service will be immediately denied.
- Staff will notify security personnel (trained volunteers or Elizabeth Police Department members), who will escort the individual to a designated safe area away from alcohol service zones.
- If necessary, transportation (e.g., taxi, rideshare) will be arranged, or law enforcement will be contacted if the individual poses a risk to themselves or others.
- **Documentation:** Incidents involving intoxicated individuals will be logged with details including time, description, and actions taken.

5. Preventing Underage Consumption and Purchases

Age Verification:

- All individuals purchasing or consuming alcohol will present valid, government-issued photo identification at the point of sale or entry.
- Wristbands will be issued only to those 21 and older by TIPS-trained staff, and alcohol service will be restricted to individuals displaying these wristbands.
- **Staff Oversight:** TIPS-certified event staff and security (including trained volunteers and at least two members of the Elizabeth Police Department) will monitor the event to prevent alcohol from being passed to underage persons.
- **Signage:** Clear signage will be posted at all alcohol service areas stating: "No alcohol sales or service to individuals under 21. ID required."
- **Enforcement:** Any person under 21 found attempting to purchase or consume alcohol will be escorted from the alcohol service area by security personnel, and their guardian (if applicable) or law enforcement may be notified. Vendors caught serving minors will face immediate suspension of alcohol service privileges.

6. Security Personnel

• **Staffing:** Security on site will include trained volunteers and a minimum of two members of the Elizabeth Police Department. These individuals will assist with monitoring entrances, exits, and the licensed area to ensure compliance with this plan and local regulations.
