Officers notified EPD's Community Services Division for further investigation. After the completion of their investigation, the animal was determined to be a hybrid and was therefore legal to possess.

25-2035	Downed Power Line	EPD responded to a downed powerline at a local construction site. In conjunction with the Elizabeth Fire Rescue (EFR), the site was made safe, and no one was injured. The utility company was notified, and an incident report was drafted.
25-1889	Assist to Elbert County	EPD Officers assigned to the regional SWAT team took part in a SWAT operation for a warrant service.
25-1897	Assist to Elbert County	EPD Officers assigned to the regional SWAT team took part in a SWAT operation for a barricaded subject with a weapon.
25-2074	Warrant Arrest	EPD located a suspect who had an active warrant for their arrest. Once their identity and the warrant were confirmed, the party was arrested and booked into the Elbert County Jail.
25-2107	Animal Cruelty	EPD responded to a local store on a report that a juvenile party was beating a dog. Upon arrival, officers could not locate the suspect, who had left the scene prior to their arrival.
25-2072	Motor Vehicle Theft	EPD took a report of a motor vehicle theft. After investigation, it was determined the vehicle was not stolen out of EPD's jurisdiction. The proper agency was notified and the report forwarded to them for further investigation.
25-1841	Child Abuse	EPD responded to a local school on report of child abuse. After investigation, it was determined that no crime had occurred. The Elbert County Department of Human Services (DHS) was notified.
25-2150	Found Property	A citizen turned in a handheld radio to EPD. As the owner could not be located, the radio was

25-2195	Illegal Burn	EPD responded to a reported grass fire in Town. Once on scene, Officers identified two (2) juveniles started the fire recklessly. The juveniles were issued municipal summons.
25-0584	Burglary	EPD closed a case on a burglary investigation. Due to lack of cooperation from the victim, and no corroborating evidence, this case was closed due to a lack of information.
25-1993	Burglary	EPD responded to a reported illegal burn. During the investigation, it was believed the suspect was committing burglary at the property when the burning occurred. After investigation, there was insufficient probable cause to support criminal charges.
25-2188	Assist to Elbert County	EPD responded to assist Elbert County on a DUI. EPD assisted by completing an I-9000 test on the suspect.
25-2131	Harassment	EPD investigated harassment involving several juveniles. After investigation, the suspect was issued a municipal summons.
25-1651	Domestic Violence	EPD concluded an investigation into a physical domestic violence case. Probable cause supported felony charges against the suspect, and an arrest warrant was issued.
25-1907	Sex Offense	EPD closed an investigation into alleged illicit pictures on a juvenile's phone. Probable cause did not exist to support criminal charges.
25-1757	Financial Crimes	EPD was made aware of a local business that was associated with a fraudulent car selling ring. After

		investigation, it was found that the business's name was being falsely used.
25-2177	Theft	While on an unrelated call, an EPD Officer stopped an in-progress shoplifting. The investigation revealed that the suspect had just stolen from the business and was in the process of trying to flee when the Officer stopped them. The suspect was issued a municipal summons, and the value of the merchandise was recovered.
25-2233	Motor Vehicle Crash	EPD responded to a two-vehicle crash. The driver who violated the Model Traffic Code was issued a municipal summons for a traffic offense.
25-2306	Mental Health Hold	Several EPD Officers responded to a suicidal subject. Upon contacting the subject, it was determined they needed further evaluation. EPD contacted the Mobile Crisis Clinician to respond and evaluate the subject. After the evaluation, it was determined the subject was an imminent harm to themselves. They were placed in protective custody and taken to a mental health facility.
