Case/Incident Number:	Call Type:	Details:
24-1747	Stolen Property	A citizen brought in an item they had purchased on a social media platform. The property was then discovered to be stolen. The citizen turned in the property to EPD. The suspect who sold the citizen the property could not be located, and the crime occurred in another jurisdiction. The proper jurisdiction was notified of the case.
24-1576	Assault	EPD responded to a fight that occurred at a local school. Upon investigation, there was insufficient probable cause to support criminal charges. The case was turned over to the school for disciplinary action.
24-1827	Found Property	EPD had a wallet turned into station with an unknown white powder in the wallet. The wallet was safely booked into the property room. The owner was unable to be located.
24-1813	Child Abuse	EPD conducted a preliminary investigation into child abuse. After initial investigation, the alleged crime did not occur within the Town of Elizabeth.
24-1821	Driving Under the Influence	EPD responded to a motor vehicle crash. The driver at fault for the crash was found to be in a state of intoxication. The driver was subsequently arrested and booked into the Elbert County Jail.
24-1832	Warrant Arrest	EPD received a Flock hit for a vehicle associated with a warrant. EPD located the vehicle and subsequently arrested the party with the outstanding warrant.
24-1846	Driving Under the Influence	EPD received several reports of a possible drunk driver. EPD located the vehicle and found the driver to be in a state of intoxication. The driver was subsequently arrested and booked into the Elbert County Jail.
24-1713	Sex Offense	EPD responded to a local school on reports of students engaging in promiscuous behavior. The juveniles were issued municipal summons for a criminal offense.

24-1765	Sex Offense	EPD responded to a local school on a reported sex offense. After investigation, there was insufficient evidence to support criminal charges.
24-1207	Municipal Ordinance Violation	EPD Community Services Division closed a case on a property that had an accumulation of debris. The property owner came into compliance.
24-1855	Assist to Elbert County	Several EPD Officers responded to assist the Elbert County Sheriff's Office (ECSO) on a stolen vehicle. EPD assisted in detaining the parties. The case was turned over to ECSO.
24-1839	Animal Complaint	EPD Community Services Division located two dogs running at large on State Highway 86. The dogs were impounded at the Town kennel and the owner was located. The owner was issued a municipal summons.
24-1443	Motor Vehicle Accident	EPD responded to a two-vehicle motor vehicle crash. EPD took a crash report on the accident. There were no injuries.
24-1933	Civil Assist	EPD responded to a report of damaged property. After investigation, the case was a civil matter and no criminal charges applied.
24-1085	Disturbing the Peace	EPD responded to a local bar on report of a fight. EPD identified the aggravating party and issued them a municipal summons.
