Good morning, Mayor, Mayor Pro Tem, and Members of the Board. Here is your newest weekly update.

Workshop on January 28th. Staff is planning on a workshop beginning at 6:30pm for next Tuesday's meeting. The purpose is to walk through any questions or concerns that you may have regarding The Depot parking lot; its location; possible land transactions; etc. Staff will be present to walk through construction, budget, and other considerations.

RAISE Grant Update. With the change in federal administration, and the executive orders issued to date, it is not entirely clear how the grant will proceed. We were asked to provide alternative calculations below the \$3M grant request as well, to provide an alternative path for receiving the funds. Regardless, we are still working on this project and anticipate having everything submitted before the deadline.

135th Anniversary. As a reminder, the Board will need to consider what, if anything, they wish to do this year to commemorate the 135th anniversary of the Town of Elizabeth. Currently, we have set aside September 20th, 27th or October 4th for the annual Birthday Bash Movie Night. The dates are tentative until the School District releases its new calendar for the upcoming school year. From there, we can select a date.

525 Dale Court Agenda Item. It appears that the lender in this matter is unwilling/unable to proceed with the easement provided. There is a chance that the matter is resolved in advance of Tuesday's meeting, but highly doubtful. I would anticipate an amendment to the agenda Tuesday to remove this item from consideration.

Information on Community and Senior Activity Center. A member of the Board has asked for the background information on the Center, and we are currently pulling that together. There has been a bit of a time delay, due to working on the DOT grant for sidewalks along HWY 86. We should have that information available next week. If you would like a copy of the documentation as well, please just let me know and we can get additional sets run off. Again, sorry for the delay in getting this completed.

Executive Session on February 25th. I would like to have an executive session on the 25th to likely discuss a couple of topics. Corey will be available that day for the exec as well, and it is somewhat time sensitive. We will try to keep the regular meeting as short as possible to limit

the overall meeting time.
