24-1142	Suicidal Subject	EPD responded to a subject who had expressed suicidal ideations. After speaking with the subject, they told Officers they wanted to go to the hospital voluntarily on a mental health transport. Elizabeth Fire Rescue transported the subject to a mental health facility.







