

RESOLUTION NUMBER 26-02

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF EUSTIS, FLORIDA, AUTHORIZING THE CITY MANAGER AND CHIEF OF POLICE TO PURCHASE A SPEED RADAR TRAILER UTILIZING FDOT GRANT FUNDS; AND AUTHORIZING THE CITY'S FINANCE DIRECTOR TO MAKE THE NECESSARY BUDGET ADJUSTMENTS TO REFLECT THE EXPENDITURE AND REIMBURSEMENT OF THESE FUNDS.

WHEREAS, the Florida Department of Transportation (FDOT) provides reimbursement funding to local law enforcement agencies for the purchase of eligible speed enforcement equipment; and

WHEREAS, the Eustis Police Department has identified the need to purchase a SAM 3 Speed Radar Trailer to enhance traffic enforcement, reduce speeding, and improve roadway safety; and

WHEREAS, the cost of the radar trailer is \$11,450.00, and this cost is fully reimbursable through the FDOT Grant; and

WHEREAS, the radar trailer will assist the Police Department in responding to speeding complaints, collecting traffic data, and deploying mobile traffic-calming measures throughout the City; and

WHEREAS, Generally Accepted Accounting Principles necessitate that the expenditure and reimbursement of the funds be properly recorded within the appropriate fiscal year.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Eustis, Florida, as follows:

1. The City Manager and Chief of Police are hereby authorized to proceed with the purchase of one (1) SAM 3 Speed Radar Trailer in the amount of \$11,450.00, to be reimbursed through the FDOT Grant.
2. The City's Finance Director is authorized to make all necessary budget adjustments to reflect the expenditure and subsequent reimbursement of the grant funds.
