RESOLUTION NUMBER 25-87

A RESOLUTION BY THE CITY COMMISSION OF THE CITY OF EUSTIS, LAKE COUNTY, FLORIDA, AUTHORIZING THE USE OF JUSTICE ASSISTANCE GRANT – COUNTYWIDE (JAG-C) FUNDS IN THE AMOUNT OF \$4,947.75 FOR THE PURCHASE OF 45 FLYING CROSS LIT SAFETY VESTS FOR THE EUSTIS POLICE DEPARTMENT.

WHEREAS, the City of Eustis Police Department is committed to ensuring the safety of its officers during operations conducted in low-light and high-traffic conditions; and

WHEREAS, officers frequently respond to roadway incidents, crash investigations, and adverse weather events where increased visibility is essential for safety; and

WHEREAS, the Flying Cross LIT Safety Vest enhances officer visibility through integrated under-lit LED strips, an adjustable touch dimmer, ANSI 2 visibility certification, and a low-cut front zipper design compatible with body-worn cameras; and

WHEREAS, the total cost for the purchase of the Flying Cross LIT Safety Vests is **\$4,947.75**; and

WHEREAS, the City of Eustis Police Department has been awarded funding through the Justice Assistance Grant – Countywide (JAG-C) in the amount of \$5,000, which will fully cover the cost of the vests with no additional expense to the City's General Fund; and

WHEREAS, the acquisition of the Flying Cross LIT Safety Vests will enhance officer safety, visibility, and operational effectiveness in the field.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF EUSTIS, LAKE COUNTY, FLORIDA:

SECTION 1. The City Commission hereby authorizes the use of **JAG-C grant funds in the amount of \$4,947.75** for the purchase of Flying Cross LIT Safety Vests for the Eustis Police Department.

SECTION 2. The City Commission finds that the purchase of this safety equipment supports the City's ongoing efforts to provide officers with tools and equipment that enhance safety and performance.

SECTION 3. This resolution shall become effective immediately upon adoption.
