## **RESOLUTION NUMBER 25-90**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF EUSTIS, FLORIDA, APPROVING A WAIVER FOR THE SIZE AND PLACEMENT OF A TEXTILE RECYCLING COLLECTION BIN/SHED AT 2910 DILLARD ROAD, PURSUANT TO ORDINANCE NO. 21-07; PROVIDING FOR CONDITIONS OF APPROVAL.

**WHEREAS**, the Life Community Church, in partnership with St. Pauly Textile East, Inc., has submitted an application requesting approval for the installation of a textile recycling collection bin/shed on approximately 9.5 acres of property located at 2910 Dillard Road, as depicted in Exhibit A; and

WHEREAS, the subject property is more particularly described as follows:

**WHEREAS**, the property located at 2910 Dillard Road holds a Land Use Designation of Public/Institutional and a Design District Designation of Suburban Corridor; and

**WHEREAS**, the property is currently developed and utilized as a church facility, serving a community services function; and

**WHEREAS**, the proposed location for the textile recycling bin/shed complies with the locational criteria established in Ordinance Number 21-07; and

**WHEREAS**, the proposed size of the bin/shed has been deemed appropriate and consistent with the intent of Ordinance Number 21-07; and

**WHEREAS**, the City Commission has reviewed the Business Tax Receipt application and supporting documentation, including Exhibits A and B, and finds the proposed textile recycling bin to be in compliance with Ordinance Number 21-07.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF EUSTIS, FLORIDA, AS FOLLOWS:

**Section 1.** The textile recycling collection bin proposed for installation at 2910 Dillard Road as depicted in Exhibit A, is hereby approved.

**Section 2.** Approval of the textile recycling collection bin is contingent upon St. Pauly Textile East, Inc. adhering to the following conditions:

A. The bin shall be maintained in a clean and orderly condition and emptied at least once every fourteen (14) days, or immediately if textiles are found outside the bin (e.g., placed on top, on the ground nearby, or on adjacent structures).

- B. The area within a twenty (20) foot radius of the bin shall remain free of trash, debris, discarded items, or abandoned textiles not contained within the bin.
- C. A valid Eustis Business Tax Receipt must be maintained at all times.
- D. All other applicable provisions of Ordinance Number 21,07 shall be observed
