A RESOLUTION BY THE CITY COMMISSION OF THE CITY OF EUSTIS, LAKE COUNTY, FLORIDA, PROVIDING FOR THE PROPOSED MILLAGE RATE OF 7.5810 MILS FOR THE FISCAL YEAR 2025/26 ANNUAL BUDGET FOR THE CITY OF EUSTIS, LAKE COUNTY, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, it is the responsibility of the City of Eustis, to advise the Lake County Property Appraiser of its PROPOSED millage rate for inclusion on the 2025 annual TRIM notices, and

WHEREAS, on June 21, 2025, the City of Eustis, Lake County, Florida, held a budget workshop, and

WHEREAS, the City of Eustis, Lake County, Florida, agreed to the FY 2025/26 PROPOSED Millage Rate of 7.5810; and

WHEREAS, the City of Eustis, City Commission provided direction to staff to provide the 7.5810 millage rate to the Lake County Property Appraiser for annual TRIM notices, and

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Eustis, Lake County, Florida, as follows:

SECTION 1

That the FY 2025/26 PROPOSED operating millage rate of 7.5810 mills will be provided to the Lake County Property Appraiser to use on the 2025 TRIM notices.
