#### **RESOLUTION NUMBER 25-21**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF EUSTIS, LAKE COUNTY, FLORIDA, AUTHORIZING RE-ENGAGMENT WITH RAFTELIS FINANCIAL CONSULTANTS, INC. (RAFTELIS) TO COMPLETE A WATER, WASTEWATER, RECLAIMED WATER RATE, A WATER, WASTEWATER AND RECLAIMED WATER IMPACT FEE (UTILITY) STUDY, STORMWATER RATE AND STORMWATER IMPACT FEE (STORMWATER) STUDY AND TO INITIATE A STUDY FOR PARKS AND RECREATION, POLICE, FIRE AND LIBRARY IMPACT FEE (IMPACT FEES) STUDY IN THE AMOUNT OF \$120,800 BASED ON A PIGGYBACK CONTRACT OF AN RFP AWARDED BY DAYTONA BEACH FOR CONSULTING SERVICES RFP-19632 AND TO AUTHORIZE A GENERAL FUND BUDGET AMENDMENT TO INCREASE EXPENSES AND REDUCE FUND BALANCE IN THE AMOUNT OF \$59,650.

**WHEREAS**, on January 19, 2023, the City approved Utility and Stormwater rate studies; and

WHEREAS, Raftelis Financial Consultants, Inc. (Raftelis) submitted the winning RFP from the City of Daytona Beach, which the City piggybacked (RFP-019632) to perform the study; and

**WHEREAS**, the study was put on hold in FY 2023/24 because of concerns regarding the Eastern Wastewater Treatment Plant; and

**WHEREAS**, the City wants Raftelis to complete the Utility study at a cost of \$37,650 and;

**WHEREAS**, the City wants to have Raftelis complete the Stormwater study at a cost of \$23,500; and

**WHEREAS**, the City wants to have Raftelis perform an Impact Fee study in the amount of \$59,650; and

**NOW, THEREFORE, BE IT RESOLVED,** by the City Commission of the City of Eustis, Lake County, Florida, that:

- (1) The City Manager is hereby authorized to approve the agreement with Raftelis Financial Consultants dated March 11, 2025, in the amount of \$120,800; and
- (2) That the FY 2024/25 Adopted Budget for the General Fund is amended to increase expenses, and reduce Fund Balance in the amount of \$59,650 to cover the cost of the Impact Fee study; and

(3) The Finance Director is hereby authorized to amend the General Fund Budget in the amount of \$59,650 to cover an Impact Fee study in accordance with this Resolution.
