

RESOLUTION NUMBER 25-22

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF EUSTIS, LAKE COUNTY, FLORIDA; AMENDING THE BUDGET FOR FISCAL YEAR 2024/25 FOR THE GOVERNMENTAL AND WATER AND SEWER UTILITY GRANTS FUNDS TO ACCOUNT FOR GRANTS AWARDED IN FY 2024/25; REPEALING ALL RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Eustis, has been awarded two Justice Assistance Grants (JAG) from the Department of Justice in the amounts of \$4,428 and \$7,721, respectively; and

WHEREAS, the City of Eustis has been awarded an American Recovery Plan Act (ARPA) via Lake County in the amount of \$100,000; and

WHEREAS, there is no grant match requirement for any of the grants; and

WHEREAS, it is in the best interest of the City to amend the budget for the Governmental (018) Water and Sewer Utility (048) Grants Fund to account for the fiscal activities previously awarded grants; and

WHEREAS, the Governmental Grants Fund (018) FY 2024/25 budget will be amended as follows:

<u>JAG – Bullet Proof Vests</u>

<u>JAG – Physical Fitness Equipment</u>

WHEREAS, the Water and Sewer Utility Grants Fund (048) FY 2024/25 budget will be amended as follows:

<u>ARPA/Lake County – Johnson’s Point Septic to Sewer</u>	
048-0000-331-50-01 – Revenue	\$100,000
048-3510-351-60-01 – Expense	\$100,000

NOW, THEREFORE, BE IT RESOLVED, by the City Commission of the City of Eustis, Lake County, Florida, as follows:

Section 1

That the FY 2024/25 Adopted Budgets for the Governmental and Water and Sewer Grants Funds are amended to recognize equal amounts of revenue and expenditures for grants awarded in FY 2024/25, for a net budgetary impact of zero .

Section 2

That the Finance Director of the City of Eustis is hereby authorized to amend the FY 2024/25 adopted budgets for the Governmental and Water and Sewer Utility Grants Funds.

Section 3

That this Resolution shall take effect immediately upon its adoption.
