I respectfully submit this application for a reduction of fines associated with the code violations. I acknowledge the violations and accept responsibility for not being in compliance. However, I am requesting a reduction of fines because the non-compliance was not intentional and occurred as a result of the following.

Due to initially going under contract to sell the property, I delayed immediate corrective actions in anticipation of completing necessary repairs prior to closing. However, contractor delays significantly impacted the repair timeline, leading me to ultimately decide to sell the property as-is.

Unfortunately, the buyer experienced financing issues, and the sale fell through. Additionally, fluctuations in the housing market, changes in zoning requirements, and at one point being instructed to install a septic system further complicated the process and contributed to unanticipated delays in resolving the code violation. These combined factors prevented timely compliance despite my efforts to move the situation forward.

I have since corrected the violations in accordance with code requirements and have made every effort to cooperate fully with the Planning and Zoning Department. I am committed to maintaining compliance moving forward and meeting all applicable standards for as long as I maintain ownership of the property.

I respectfully ask the board to consider my good faith efforts, corrective actions, and the financial impact of the accrued fines. A reduction would allow me to continue making improvements and contribute positively to the community.
