A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF EUSTIS, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF A MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF CORRECTIONS RELATED TO COOPERATIVE LAW ENFORCEMENT EFFORTS BETWEEN THE EUSTIS POLICE DEPARTMENT AND THE DEPARTMENT.

WHEREAS, the Florida Department of Corrections has proposed a Memorandum of Agreement (MOA) with the City of Eustis Police Department for cooperative efforts to improve criminal justice and offender reentry services in Lake County; and

WHEREAS, said MOA outlines respective responsibilities for warrant service, offender monitoring, information sharing, and joint operations between the parties; and

WHEREAS, the Eustis Police Department has determined that participation in the MOA is in the best interest of public safety and is consistent with standard cooperative agreements in Florida.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF EUSTIS, FLORIDA:

- **Section 1.** The foregoing recitals are adopted and incorporated herein as findings of the City Commission.
- **Section 2.** The City Commission approves the MOA with the Florida Department of Corrections, attached hereto as Exhibit A.
- **Section 3.** The City Commission authorizes the Chief of Police to execute the MOA on behalf of the City.
- **Section 4.** This Resolution shall become effective immediately upon adoption.
