## **RESOLUTION NUMBER 25-70**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF EUSTIS, FLORIDA, PROVIDING FOR COMMISSION DETERMINATION OF A CODE ENFORCEMENT LIEN ON PROPERTY LOCATED AT 67 GLOVER STREET; AUTHORIZING IMPLEMENTING ACTIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Eustis, Florida established code enforcement fines against the following described property under Case Number 20-00176 and 24-00063 against Harold J. Kelly, property owner, for failing to comply with City Ordinances:

E 200 FT OF S 50 FT OF N 250 FT OF W 1/2 OF NE 1/4 OF SE 1/4 OF NW 1/4 ORB 5464 PG 1805, and

- **WHEREAS**, the City of Eustis, Florida, a Florida municipal Corporation, has recorded two Code Enforcement Liens against the subject property, totaling \$61,750, and
- **WHEREAS**, the property was in violation of city code under Case 20-00176 for 116 days before being brought into compliance resulting in a \$29,000 fine; and
- **WHEREAS**, the property was in violation of city code under Case 24-00063 for 131 days before being brought into compliance resulting in a \$32,750 fine; and
- **WHEREAS**, on May 29, 2025, the property owner submitted applications requesting that the fines be reduced to \$10,000 for Case 20-00176 and \$16,000 for Case 24-00063; and
- WHEREAS, on June 9, 2025, the Code Enforcement Board approved the requests and recommended that the City Commission reduce the accumulative fines to \$26,000 payable within 30 days; and
- **WHEREAS**, on August 9, 2025, the property owner submitted a written request during a regular scheduled Code Enforcement Board Hearing, asking the Board to reconsider its previously approved reductions and further reduce the fines to the city's administrative costs; and
- **WHEREAS**, the Board denied the property owner's new request and upheld the original fine reduction; and
- **WHEREAS,** Section 162.09(3), Florida Statutes, provides that code compliance liens run in favor of the local governing body, and the local governing body may agree to satisfy or release code compliance liens; and
- WHEREAS, the Attorney General has stated that after such liens have been recorded the local governing body, such as the City Commission, is vested with the authority to compromise, reduce, or satisfy said liens; and

**WHEREAS**, the City Commission in considering this matter may elect to compromise (including setting terms and conditions for said compromise), reduce, or satisfy said lien; and

**WHEREAS**, the Attorney General has concluded the local governing body, such as the City Commission, may delegate its authority to execute satisfactions or releases of code compliance liens so long as such delegation does not result in a complete divestiture of such liens to a private party; and

**WHEREAS**, the City Commission authorizes the City Manager to execute a release or satisfaction of lien, as may be appropriate and consistent with the City Commission's decision to compromise, reduce, or satisfy said lien.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Eustis, Florida, as follows:

- **Section 1. Recitals.** The above recitals are hereby adopted as the findings of the City Commission.
- **Section 2. Implementing Actions.** The City Manager, or his/her designee, is hereby authorized to take all administrative actions necessary to effectuate the provisions of this Resolution, including execution of satisfactions or releases of lien, acceptance of payment, and the granting of one payment extension not to exceed thirty (30) days from the effective date of this Resolution. Any such actions shall be consistent with and limited to the determination of the City Commission as set forth herein.
- <u>Section 3.</u> Lien at Issue. The City Commission has considered the code enforcement liens for Case Number 20-00176 and Case Number 24-00063 with a total current outstanding amount of \$61,750.
- Section 4. Quasi-Judicial Determination. The City Commission, having considered the recommendation of the Code Enforcement Board, and any evidence and testimony presented at hearing, hereby makes the following determination regarding the code enforcement liens in the amount of \$61,750.00 recorded against the subject property:

| The liens shall be reduced to \$26,000.00, consistent with the Board's recommendation, payable within thirty (30) days of the effective date of this Resolution, unless otherwise extended by the City Manager in accordance with Section 2; or |
