RESOLUTION NUMBER 25-69

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF EUSTIS, FLORIDA, PROVIDING FOR COMMISSION DETERMINATION OF A CODE ENFORCEMENT LIEN ON PROPERTY LOCATED AT 926 NORTH BAY STREET; AUTHORIZING IMPLEMENTING ACTIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Eustis, Florida established code enforcement fines against the following described property under Case Number 21-00845 against Shree Sadashiv Inc., property owner, for failing to comply with City Ordinances:

EUSTIS, SHOREACRES NO 3 FROM NE COR OF LOT 1 BLK B RUN S 70-55-0 W ALONG S'LY R/W LINE OF HERRICK DR A DIST OF 51 FT FOR POB, CONT S 70-55-0 W 74.99 FT, S 11-18-32 E 180 FT, N 89-35-10 E 25.65 FT, S 0-24-50 E 62.83 FT, S 89-51-50 E 193.69 FT TO W'LY R/W LINE OF SR 19 & PT A, RETURN TO POB, RUN S 19-37-15 E 75.39 FT, N 77-40-04 E 128.53 FT TO W'LY R/W LINE OF SR 19, S 08-37-0 E ALONG SAID W'LY R/W LINE 223.06 FT TO PT A, BEING PART OF LOTS 1, 2, 3, 4, 5 BLK B & PART OF NORTH BAY STREET LYING E OF BLK B & W OF BLK E & W OF SR 19 PB 6 PG 83 ORB 4815 PG 13, and

WHEREAS, the City of Eustis, Florida, a Florida municipal Corporation, recorded a Code Enforcement Lien against the subject property on September 7, 2022, in Official Record Book 6020, Page 68, in the office of the Clerk of the Circuit Court, Lake County, State of Florida; and

WHEREAS, the property was in violation of city code for 1,050 days before being brought into compliance; and

WHEREAS, the daily fines accrued to \$55,250; and

WHEREAS, on July 7, 2025, the property owner submitted an application requesting that the fines be reduced to \$20,000; and

WHEREAS, on August 11, 2025, the Code Enforcement Board approved the request and recommended that the City Commission reduce the fines to \$20,000 payable within 30 days; and

WHEREAS, Section 162.09(3), Florida Statutes, provides that code compliance liens run in favor of the local governing body, and the local governing body may agree to satisfy or release code compliance liens; and

WHEREAS, the Attorney General has stated that after such liens have been recorded the local governing body, such as the City Commission, is vested with the authority to compromise, reduce, or satisfy said liens; and

WHEREAS, the City Commission in considering this matter may elect to compromise (including setting terms and conditions for said compromise), reduce, or satisfy said lien; and

WHEREAS, the Attorney General has concluded the local governing body, such as the City Commission, may delegate its authority to execute satisfactions or releases of code compliance liens so long as such delegation does not result in a complete divestiture of such liens to a private party; and

WHEREAS, the City Commission authorizes the City Manager to execute a release or satisfaction of lien, as may be appropriate and consistent with the City Commission's decision to compromise, reduce, or satisfy said lien.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Eustis, Florida, as follows:

- **Section 1. Recitals.** The above recitals are hereby adopted as the findings of the City Commission.
- **Section 2. Implementing Actions.** The City Manager, or his/her designee, is hereby authorized to take all administrative actions necessary to effectuate the provisions of this Resolution, including execution of satisfactions or releases of lien, acceptance of payment, and the granting of one payment extension not to exceed thirty (30) days from the effective date of this Resolution. Any such actions shall be consistent with and limited to the determination of the City Commission as set forth herein.
- Section 3. Lien at Issue. The City Commission has considered the code enforcement lien for Case Number 23-00583 with a current outstanding amount of \$55,250.00.
- **Section 4. Quasi-Judicial Determination.** The City Commission, having considered the recommendation of the Code Enforcement Board, and any evidence and testimony presented at hearing, hereby makes the following determination regarding the code enforcement lien in the amount of \$55,250.00 recorded against the subject property:
