I hope this letter finds you in good health. I am writing to you, seeking your understanding and assistance regarding a recent penalty of \$7,050 that I have been assessed for non-compliance.

I fully understand the importance of adhering to the rules and regulations set forth by the Eustis Code Enforcement Board. I believe that my situation warrants a special consideration for a reduction of this penalty.

The circumstances leading to this oversight were beyond my control. I notified our architect Juan Vazquez in the month of March 2024 about updating the plans of my property (17 S Salem St Eustis) to be able to submit permits, architect Juan Vasquez said yes but he needed to charge more money. I paid the total amount he requested and the deal was for him to continue with the property plans. I honestly trusted that he was going to submit the signed plans to get the permits on time as he is a professional and should know the consequences of not doing so. Unfortunately I was out of the U.S From June 24, 2024 until August 11, 2024 due to my father passing away, due to me not being present in the U.S for 2 months I was not aware of this matter.

My arrival from Mexico was Sunday Aug 11, it was not until Aug 13 that I checked my mail and I found out that I had a hearing at the City of Eustis due to this matter. Since this day I have been behind the architect for him to sign the plans and submit permits, it was not until September 10 2024 that he submitted for permits.

Given these exceptional circumstances, I kindly request your consideration for a reduction of the penalty assessed. I believe this gesture of goodwill would not only alleviate the financial burden it represents during this challenging time but also reinforce my commitment to adhere to the guidelines moving forward.

I will take measures to ensure that such an oversight does not occur in the future. I am more than willing to provide any additional information that may be required to support my request.
