10. City Manager's Report- Craig Spencer

Craig updated on the City Hall Annex Project as far as the Fire Suppression System is under review and their almost done with that and they have ordered the vault for it and that will take four to six weeks for delivery. This project will definitely not be done by April 1st. Everything else is progressing and the Contractors do not see any other issues. Craig also stated that the Directors (City Staff) have done a great job staying on Budget and everyone has been able to come in under 3% of their Budget. Also, Craig stated that there have been some water-line issues with Hanna Ranch Project. They have to put in two new water taps in order to properly supply water to the neighborhood. This will cost \$18,000. Craig did provide that approval for them to move forward last week and the \$18,000 will come out of the Water Fund Reserves. Craig also wanted to inform council that the Librarian Director, Billy Manus has put in his notice to resign. This is a one month notice and since he did offer to help train, we will be advertising for this position starting tomorrow. Last, Craig stated through the Gexa Energy Contract the city gets provided to us an annually report that is not accurate at all since all the new projects have been going on and complete. Because of this, the contract has been terminated early with them and with this it is saving them money so they paid us \$10,000 to terminate this contract early.
