ORDINANCE NO. 790

- AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF EVERMAN, TEXAS, AUTHORIZING THE CITY MANAGER'S EXECUTION OF CORRECTION INSTRUMENTS FOR NINE LOTS IN BLOCK 3, OUT OF THE EUREKA ADDITION, SITUATED IN THE CITY OF EVERMAN, TARRANT COUNTY, TEXAS, WHICH WERE PURCHASED BY THE EVERMAN ECONOMIC DEVELOPMENT CORPORATION.
- WHEREAS, the Everman Economic Development Corporation ("EEDC") is an economic development corporation being a Type B corporation formed and governed by Chapter 505, Texas Local Government Code, and is considered an "independent foundation," formulated to provide for economic development that promotes a public purpose in the City of Everman, Texas; and
- WHEREAS, the City Council of the City of Everman, Texas ("City"), a home-rule municipality, on June 9, 2015, approved and authorized the EEDC Director to bid on and expend EEDC funds for the possible purchase of up to fourteen different parcels on Race Street, which were to be auctioned off at the Tarrant County Courthouse; and
- **WHEREAS,** on or about October 8, 2015, the EEDC successfully bid for and purchased the nine properties described in Exhibit "A" ("Properties"), attached hereto and incorporated herein by reference; and
- **WHEREAS**, the City did not make payments from municipal funds for the conveyance of, nor has the City made any claim of ownership to, the Properties; and
- **WHEREAS**, each of the instruments conveying the Properties to the EEDC, which are recorded in the Official Real Property Records of Tarrant County as described in Exhibit "A", incorrectly identify the grantee as the "City of Everman" instead of identifying the grantee as the "Everman Economic Development Corporation"; and
- **WHEREAS,** Sections 5.027 through 5.030, Texas Property Code, provide a method for filing a correction instrument to correct an ambiguity or error in a recorded original instrument of conveyance to transfer an interest in real property, including to make a nonmaterial addition, correction, or clarification of a party's name; and
- **WHEREAS,** the City and the EEDC desire to have the Properties used for economic development that primarily promotes a public purpose of the City, and
- **WHEREAS**, this City Council has determined that the correction of the conveyance instruments for these Properties will further the EEDC's ability to use the Properties for economic development that primarily promotes a public purpose of the City; and

WHEREAS, the City Council hereby approves the form and terms of the proposed correction instrument ("Correction Instrument"), attached hereto as Exhibit "B", which is intended to be filed in Tarrant County to correct the errors in each of the original instruments of conveyance of the Properties to the EEDC.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVERMAN, TEXAS, THAT:

- **SECTION 1. Findings.** The City Council hereby deems the foregoing recitals above to be true and accurate findings that are incorporated into this Ordinance for all purposes.
- **SECTION 2. Authority of City Manager.** The City Manager of the City of Everman is hereby authorized and directed to execute, on behalf of the City of Everman, a Correction Instrument, the form of which is attached hereto as Exhibit "B", and all documents associated therewith, to effectuate the correction of each of the nine original conveyance instruments for the Properties described in Exhibit "A" to reflect the Everman Economic Development Corporation as the correct grantee.
- **SECTION 3. Severability.** If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, the invalidity or the unenforceability will not affect any other provisions or applications of this Ordinance that can be given effect without the invalid provision.
- **SECTION 4. Effective Date.** This Ordinance shall be effective immediately upon passage and be in full force and effect after its adoption.
- **SECTION 5. Open Meetings.** It is hereby officially found and determined that the meeting at which the City Council passed this ordinance was open to the public and that the City gave public notice of the time, place, and purpose of said meeting as required by the Open Meetings Act, Texas Government Code, Chapter 551.
