




THE REMOVAL OF THE OLD FOREMANS HOUSE FOR THE NEW "civic center"







### ADJACENCY DIAGRAMS: PRELIM STUDIES

### STAKEHOLDERS SUMMARY

#### CITY COUNCIL

- THE ABILITY TO HOUSE 10 COUNCIL, BOARD AND COMMITTEE MEMBERS, INCLUDING THE MANAGER, SECRETARY AND ATTORNEY.
- WANT TO PROTECT THE DAIS FROM THE PUBLIC WITH THE POTENTIAL USE OF PARTITIONS.

#### **ELECTIONS**

- HOLD ELECTIONS JOINTLY WITH BEXAR AND KENDALL COUNTY AND THAT 1,200 SF IS TO BE CONSIDERED FOR EACH COUNTY.
- DURING VOTING PERIOD, THE EVENT SPACE MUST BE LOCKED FROM THE REST OF THE BUILDING AFTER HOURS FOR THE ENTIRE PERIOD OF VOTING.

#### HOMEOWNERS ASSOCIATION

 HOSTS A YEARLY MEETING FOR ABOUT 175-200 PEOPLE WHETHER IN PERSON OR REMOTE AND AUDIO/VISUALS SHOULD BE CONSIDERED.

#### **PLANNING & ZONING**

 HOSTS A SMALL MEETING FOR ABOUT 20 PEOPLE.

#### **ADDITONAL CONSIDERATIONS**

- WANT THE OPPORTUNITY TO HOUSE MULTIPLE EVENTS AT THE SAME TIME.
- OUTDOOR POWER FOR HOA CHRISTMAS DECORATIONS.
- REQUESTED STORAGE FOR LOCAL ORGANIZATIONS USING THE BUILDING ON A REGULAR BASIS.







### EVENT HALL FURNITURE LAYOUT
