OPEN MEETING

Consideration and possible action approving the first reading of an ordinance amending the Fair Oaks Ranch Code of Ordinances Chapter 12 Traffic and Vehicles, Article 12.01 General Provisions, Section 12.01.003(3) by reducing the maximum speed limit on Rolling Acres Trail from Ammann Road to Silver Spur Trail to 30 miles per hour

Made by Council Member Rhoden, seconded by Council Member Olvera, to approve the first reading of an ordinance amending the City of Fair Oaks Ranch Code of Ordinances, Chapter 12 Traffic and Vehicles, Article 12.01 General Provisions, Section 12.01.003(3) by reducing the maximum speed limit on Rolling Acres Trail from Ammann Road to Silver Spur Trail to the 30 mph.

Council Member Olvera requested that staff bring forward a future agenda item to consider reducing the speed limit on Silver Spur Trail and Post Oak Trail in order to maintain consistency in the area.

WORKSHOP

9. Tree Mitigation Options for the WWTP Phase 1 Expansion and Plant 5 Ground Storage Tank Projects

Project Manager Kelsey Delgado led a workshop on mitigation options related to the City's Wastewater Treatment Plant Expansion and Plant 5 Ground Storage Tank Projects. Council directed staff to pursue a free tree giveaway program allowing residents to plant trees on their own property at an estimated cost of \$5,000.

10. Proposed amendments to the City's Financial Management Policy, Fund Balance/Reserves Policy, and Debt Management Policy

Director of Finance Summer Fleming led a workshop on proposed amendments to the City's Financial Management Policy, Fund Balance/Reserves Policy, and Debt Management Policy. Council did not request any substantive changes to the proposed amendments. A resolution to adopt the amendments will be presented at the next City Council meeting.

Mayor Maxton announced the following upcoming events and reminders: National Night Out will take place on Tuesday, October 7, 2025, with the Fair Oaks Ranch Police Department and Bexar County Emergency Services District #4 Fire Department visiting multiple locations throughout the City. He further noted a temporary one-lane closure on Dietz Elkhorn east of the Dietz Elkhorn/Fair Oaks Parkway intersection on Friday, October 3, 2025, from 9:00 AM to 3:00 PM; flaggers will be directing traffic, and residents are encouraged to avoid the area if possible. Mayor Maxton also invited residents to attend the Police Department's annual Trunk or Treat event on Saturday, October 25, 2025, at 6:00 PM in the Fair Oaks Ranch Elementary parking lot. Lastly, he announced that the deadline to register for the November 4, 2025 Constitutional Amendment Election is Monday, October 6, 2025. Early Voting will begin on October 20, 2025. Bexar County residents may cast ballots at the Fair Oaks Ranch Police Station. Comal and Kendall County residents were encouraged to confirm their polling locations with their respective counties.
