The following citizens addressed the Commission regarding the Mixed-Use Development agenda item:

| Teal Harris     | Thanked the Commission for volunteering on the P&Z Commission and encouraged continued efforts to be good stewards of the City.  |
| Rebecca Terrell | Voiced her concerns that the proposed development would potentially have a detrimental effect on the police department, schools, traffic, Camp Bullis, trees, and property values.                                     |
| Chris Cook      | Questioned whether rental properties applied to mixed-used development and voiced preference of privately owned properties. Mr. Cook also mentioned concerns of the impacts 207 units would have on water and traffic. |
| Muriel Landford | Expressed her desire to keep the "small community feel". She also voiced her preference of owners versus renters.  |
| Shari St. Clair | Disagreed with the notion that development was inevitable. She spoke regarding the negative impact this development would have on the community and her concern regarding "dark skies", water and police coverage.     |
| Al Schmidt      | Referenced "The Reserve Development" in regard to water availability and noted that the proposed development is worse due to its increased density.  |

3. To reintroduce the golf cart parking requirements.
