MINUTES

OPEN MEETING

1. Roll Call - Declaration of a Quorum

Council Present: Mayor Maxton and Council Members: Rhoden, Koerner, Parker, and

With a quorum present, the meeting was called to order at 6:30 PM.

Elkorn Ridge Development SA, LLC, and Elkhorn Ridge SA, LLC; a \$10,000 monetary donation from ROW at Dietz Elkhorn, LLC; and a monetary donation up to \$10,000 from Vantage at Fair Oaks, LLC for the design and construction of the Dietz Elkhorn Sidewalk Project and authorizing the City Manager to execute all applicable documents.
