- 4. Identification of implementation steps
- 5. Review of redlined version by P & Z
- 6. Chapter-by-Chapter review by P & Z
- 7. Legal review
- 8. Preparation of a final redline version
- 9. Consideration of redlined version and recommendation by P & Z on March 9, 2023

- 10. Directive to categorize changes into topics by City Council on April 20, 2023
- 11. Approval of topics by City Council on May 18, 2023
- 12. Preparation of PH draft
- 13. Legal review (state law changes)
- 14. P & Z courtesy review
- 15. Review of first set of amendments for Chapters 1-3 by P & Z on June 6, 2023
- 16. Legal review (state law changes)
- 17. P & Z Public Hearing July 13, 2023
