On May 1, 2024 the Fallon Police Department received an application for City Liquor License from Mr. Kip Collins of 1058 Greenbrook Place in Fernley, Nevada 89408. Mr. Collins is seeking an "on-premise" and "Off-Premise" city liquor license as the store manager for two Dotty's Casino locations at, 2111 West Williams Avenue and 2197 Casey Road Suite #106 within the City of Fallon.

A review of Mr. Collins' references were all very favorable, with all speaking very highly of him.

I have performed a basic criminal background check which included the Fallon Police Local Database and CPClear. I found that Mr. Collins has no known violation or convictions of law.

On May 7, 2024 I interviewed Mr. Collins and learned that he would be responsible for both business' and the sales and service of alcoholic beverages.

I have provided a supplemental form in which Mr. Collins signed, indicating that he understands his responsibilities as they relate to the laws regarding underage drinking. Additionally, I have provided Mr. Collins with a printed copy of section 5.20 of the Fallon Municipal Code which relates to the responsibility of serving alcoholic beverages.

I have concluded that Mr. Collins has passed a limited background check.
