Weekends are still busy and full staffing will continue every weekend through Labor Day. As the temperatures continue to be hot, people are reminded to stay hydrated and be conscious of too much activity in the heat. As always, lifeguards are always encouraging swimmers to always swim in front of a lifeguard tower and always seek shelter indoors when lightning is present.
- The next First Friday will be on September 6. Entries are now being accepted for the city photo contest. Winning photos will be displayed at First Friday.
- The beach nourishment project has reached the pier and should be complete within the next two weeks. People are being urged to keep clear of the construction areas as the project continues.
- As the 2024 Junior Lifeguard season has ended, ocean rescue staff are inventorying out equipment and supplies to determine needs for next summer. Planning has also begun for the draft of the 2025 parent handbook.
- The Rotary Club of Flagler Beach has been approved for a community safety grant which will be used to donate three automatic external defibrillators (AEDs) to the Flagler Beach lifeguards.

The following are the weekly highlights;

- Joint SOG/SOP Committee

The Joint SOG/SOP Committee was formulated a little over a year ago. The mindset was to gather senior fire officers and review guidelines and policies that three fire agencies in the county could share. There are many functions of the fire service that are standard, why not have the exact policies within each agency, so there is no question of approach for even the newest firefighter. This committee has completed many shared policies and the plan has worked well towards incident responses. The committee has completed the latest policies and submitted them to the three executive chiefs for approval. Those policies include Incident Command/Staging Apparatus, Incident Command/Managing the Incident and Establishing Command. The policies have been approved by the three executive chiefs.

- Structural Collapse Training

Lieutenant Greg Evans has been working towards certification in Urban Search and Rescue (USAR). He is attending his latest class this week, which is FLUSAR Operations Level for Structural Collapse. The Florida Urban Search and Rescue System will conduct operations at technical rescue incidents safely and effectively based on hazard analysis, risk management, training level of personnel and availability of internal and external resources. Personnel who are to be trained to the Operations Level for Structural Collapse must have understanding of NFPA 1670 5-2 Structural Collapse Awareness level prior to starting the Operations level training. At a successful completion of the Operations level training, the candidate will have an understanding of the functions and developments of NFPA 1670 5-3.

- Training and Exercise Group Meeting

The Training and Exercise Group is the committee that researches and identifies significant incident training within the county. The group held their latest meeting at the EOC this week. The first order of business was to conduct a debriefing of the Active Assailant Training held at FPC. The group also discussed the upcoming training schedule that will be hosted in the region. Deputy Chief Cox will disperse the training schedule to all FBFD staff. Before closing the meeting, the group addressed possibly being involved in the Northeast Local Emergency Planning Committee.

- MACH Alert Overview Meeting

MACH Alert is the automated system utilized in the county that advises public safety personnel within the county of incoming emergency calls. There was a MACH Alert Overview Meeting also held at the EOC. During the meeting, the topic of current issues was addressed with Flagler County IT. The plan involves going through the discrepancies list to make improvements to the current system in 2025. Exploring new options is the goal. A Motorola representative will be working directly with Flagler County Innovative Technologies in the meantime.

- Push-In Ceremony for the new Fireflight Helicopter

FCFR has been in the process for the last year of constructing and obtaining the new Fireflight Rescue Helicopter. As you are aware, there were some structural discrepancies noted last month when the county was planning to take delivery and this in turn obviously delayed the ceremony. On August 14th, FCFR's Senior Pilot (Todd Whaley) flew to Bristol Tennessee for final inspection and to take possession of the helicopter. Yesterday the Push-In Ceremony was finally conducted and FCFR officially changed from the old platform to the new. The ceremony was held at the Flagler County Hanger and Deputy Chiefs Blanchett, Cox, Chief Doughney and myself represented the city.

- Continual Education Unit

Staff was assigned a continual education unit called Understanding Autism Spectrum Disorder for first Responders. The fire service as whole is experiencing more and more calls for patients suffering with this disorder. As previously reported, Autism Awareness stickers are now being offered at the fire house. The stickers can be displayed on homes and vehicles, advising first responders that they could be treating an Autistic patient. Upon successful completion of the course, there are several objectives expected to be obtained by the firefighters. Understand the basics of Autism Spectrum Disorder (ASD), identify individuals who may have ASD, and the mental and physical issues that may coexist with ASD. Identify the potential difficulties in interacting with an individual with ASD and the different behaviors, communication barrier and social skills that may impact a first responder encounter. Recognize how to approach an individual with ASD and the tools that may be used to interact with the individual.

- Impact Issues

There are no scheduled special events to take place this weekend. FBOR and the FBFD are expecting many beachgoers and thousands of visitors in the city.



- Bravery Medals

It was a true honor for all those in attendance to be recognized at the Commission Meeting last Thursday. As stated in the meeting, Lieutenant Evans, Driver/Engineer Prince and Firefighter/Paramedic Dave Lawrence went above and beyond the call of duty on the night of March 5th, 2024. For these three firefighters to enter the hot-zone of an active assailant scene was a display of ultimate courage. I may be biased, but I thought department members outfitted in their Class A uniforms looked very sharp. It meant a lot to Lieutenant Evans and D/E Prince to be recognized by elected officials, city administration, local residents and co-workers. The department looks forward to future recognitions in the city chambers.

- Leadership Seminar (Deputy Chief Cox)

I submitted an entry in a recent report of a leadership seminar that Deputy Chief Cox would be attending. The following is a brief narrative of the event submitted by DC Cox. "On Tuesday August 20th, I was able to attend the Fire Department Leadership Seminar hosted by Deltona Fire Department. The lecture speaker was Retired Miami Dade Fire Chief Dave Downey. Presented were the principles of leadership and how leaders must understand their intentions and how actions define the team. Topics such as culture, the importance of becoming a student of leadership, development, and refining techniques to lead men and women in the fire service"

- Chief Officer Class (Lieutenant Rainey)

Lieutenant Rainey recently attended the Chief Officer Class. The following report is her account of the class. "The Chief Officer Class was a 60-hour course that entailed a combination of classroom and practical application exercises. The course fulfilled one of the requirements for NFPA 1021 Fire Officer III certification. Palm Coast Fire Department's Deputy Chief Bradd Clark instructed the class and presented the principles of management theory and its application to the fire service. Chief Clark has 40 years of experience in the fire service, with 30 of those in Fire Chief positions. His humility, career experience, and passion for this field added an irreplicable dynamic to the covered topics: such as communications, professional development, community and intergovernmental relations, human resources, legal issues, strategic planning, public education, budget and financial issues and emergency management.

One of the required assignments entailed an oral report on an innovation that your agency has participated in. I decided to present our city's public safety drone program and how this unique, new tool has enabled first responders in providing more efficient and rapid responses to a variety of emergency situations.

The class included members from the Palm Coast Fire Department, Flagler County Fire Rescue, Deltona Fire Department and myself. This learning experience was rewarding in more ways than one and I thank you for the opportunity to attend."

- Pump Operator Course (FF/EMT Strickland)

I recently reported on the internal Driver/Engineer clearing process for the department. Obviously, part of the process includes obtaining State Certification as a Driver/Engineer. FF/EMT Strickland is one of the department's firefighters going through the clearing process and he attended the Pump Operator Course at PCFD Station 25. To be certified as a Driver/Engineer in the State of Florida, an individual must successfully complete 80 hours of basic certification training for Apparatus and Pump Operators, or have received equivalent training in another state and pass a written exam. FF Strickland will be attending the Apparatus Operator portion of the class over the next few weeks.

- Quarterly Partners Meeting

Flagler County Emergency Management conducted the quarterly Partners Meeting via Microsoft Teams. During the meeting upcoming training and classes were discussed as well as debriefing of the most recent active assailant training that was hosted at Flagler Palm Coast High School. The weather outlook was presented along with the status of the 2024 hurricane season. The current training schedule will be distributed to FBFD staff.

- Staff Evaluations

The department has been conducting evaluations for the last couple weeks. In recent years, assessments are completed with an approach that makes more sense to everyone. I evaluate the Deputy Chief, Fire Marshal and Ocean Rescue Director. Deputy Chief Cox evaluates the three lieutenants and the lieutenants assess their crews. Once completed, Deputy chief Cox and I will review all evaluations provide final signatures. I am very proud of the work/effort produced by staff this past year and the evaluations speak to that. Department evaluations have been electronically submitted to Katherine.

- Impact Issues

The Hope Foundation Overdose Awareness Walk is taking place on Saturday and will end in Veterans Park. FBOR and the FBFD are also expecting many beachgoers over the Labor Day Holiday weekend and thousands of visitors in the city.



The following are the weekly highlights;

- CPR for Cats & Dogs

The fire department has been carrying pet oxygen masks on board our units for several years. There were a few times over the years that oxygen treatments were administered to cats & dogs. Combined with compressions, these treatments have been pivotal in saving the lives of animals. I was approached by one of our FCFR's members (FF/PM Kevin Feldman) that advised me there were newer employees of both agencies that are not trained in this practice. FF/PM Feldman visited the Salty Paws Animal Clinic and inquired if this training could be provided to department members. One of the clinic's veterinarians (Dr. Carrie Coffee) agreed to provide the training and will be visiting the station over the next couple weeks to instruct the course to staff.

- In-Service Training on ResQCPR Pump

A few weeks ago, I advised that the department received its new ResQCPR Pump that had been on back order for several months. I also stated in that report that Lt. Rainey was the most knowledgeable of this new piece of equipment and she would be training staff of the capabilities. Lt. Rainey has been training staff, but there were a few questions regarding the new pump. Yesterday, a representative from the Zoll Medical Co. worked with Lt. Rainey on all the pump's capabilities. The pump is designed to provide more efficient and thorough compressions during CPR. Considering that quality and continual compressions is the new standard for the American Heart Association, properly utilizing the pump is paramount for the department. Lt. Rainey will pass the latest knowledge obtained to the rest of staff.

- Upcoming Scarecrow Event

Last year Flagler Beach Creates sponsored the Scarecrows of Flagler Beach. The mindset behind the event is to celebrate the creative nature of our community and to welcome in fall. Several city departments and local businesses displayed scarecrows with a theme in front of their buildings and store fronts. I was contacted by Flagler Beach Creates member (Kathy Wilcox) to invite the fire department to participate in the 2nd Annual Scarecrows of Flagler Beach. Last year, Volunteer Firefighter (Carrie Cardascia) created a firefighter scarecrow and displayed it in front of the fire house. The department was proud and appreciative to place 1st in the contest. The event will run for the month of October and FF Cardascia will be creating another scarecrow for the department this year. All department members are hoping to bring home the first-place ribbon again this year.

- Large Scale Incident Training Meeting

Deputy Chief Cox sat in on the After-Action Meeting for the 2024 Full Scale exercise with all participating agencies. The group discussed the strengths and weaknesses of the evolution and what to focus on between now and the next

evolution. Some of the following items identified were Unified Command communications, treatment/triage/transport, MCI training, adding qualifications forms pre-event, self-dispatching, Rescue Task Force and equipment stabilization. All participants will complete an objectives list to help build off of.

- 911 Ceremony

The FBFD has participated in the 911 Ceremony since it began in the city. This year is no different and there will be seven department members in attendance at Veterans Park for the ceremony. The members in attendance will be outfitted in our new Class A uniforms and I have to say once again, everyone looks very sharp in these uniforms. Department members will also walk in the procession, attend the Blue Mass and enjoy an early lunch a Santa Maria Del Mar Catholic Church. It was a great and the ultimate sacrifice given by members of public safety on that terrible day. Department members are always honored to pay tribute to those heroes.

- Maintenance Issue with City Drone

As previously reported, all the public safety drone operators completed recertification, completed new requirements and flight hours. The operators have continued with proficiency hours, when maintenance issue occurred. There was an issue with the obstacle avoidance system. Chief Pilot (Officer Keith Jones) shut down this system and flew the drone multiple times. The Skydio Co. and Commander Dopp (FCSO) were both consulted before reactivating the obstacle avoidance system. Once reactivated, the drone was operating properly. I give much credit to Officer Jones for trouble shooting and resolving the issue.

- Impact Issues

There are no scheduled events to place this weekend. FBOR and the FBFD are expecting many beachgoers and thousands of visitors in the city.



In August, we produced 18,614,000 gallons of drinking water. Average 600,452 gallons. This amount was 839,000 gallons greater than the amount we treated in July. The rainfall for August was 3.35 inches. We used 19,700 Gallons at the plant and used 16,733 Gallons for irrigation. The fire department used 10,000 gallons. Flushed the North End of town due to low chlorine residual. We used 863,600 gallons. We flushed Lakeshore Dr. due to low chlorine residual. We used 7,601 gallons.

We have routine duties that we perform every day on each of our shifts. We collect samples every hour to make sure we keep the chemistry of the drinking water within the parameters for Florida Department of Environmental Protection Agency. We regularly perform over 200 tests on the City water and raw water daily between the three shifts. We do routine plant maintenance. We mow the plant grounds. We collect monthly samples from all 6 Wells for statics and drawdowns. We collect quarterly samples from all 6 Wells for St. Johns River Water Management. We keep daily records for our monthly reports that are required to be turned in to the Florida Department of Environmental Protection Agency. We also do quarterly reports for Florida Department of Environmental Protection Agency on disinfection byproducts. We have the midnight shift flush the trains with high pH permeate water. We do yearly TTHM and HAA5 tests. We clean both de-gasifiers every two weeks.

DEP requires us to take five bacteriological samples from the distribution system monthly, according to our population. All samples passed on August 8th.

I have Santiago performing weekly vehicle checks. He checks all the fluids such as Brake fluid, windshield wiper fluid, transmission fluid, and all the lights.

We collected our monthly Bacteriological tests.

We submitted our monthly report to the Florida Department of Environmental Protection Agency.

Gospel Gardens is working on plant landscaping.

We collected our monthly Well samples, drawdowns, and statics. While collecting our monthly Well samples. Staff sprayed bleach at Wells 10 & 11 for weed control.

We started collecting our triennial Lead and Copper samples for the Florida Department of Protection Agency. We submitted our triennial Lead and Copper samples to the lab for analysis. We got the results from the lab and they were all great.

Ehab and staff repaired broken water lines and control line to clearwell damaged by the Demolition contractor.

North Florida Waste and Demolition finished demolishing the old plant vaults.

We collecting our monthly meter readings.

Staff cleaned both Degasifiers throughout the month.

We are going to have CCI cameras Well 11 to see why the Conductivity and Chlorides are getting higher. We ran a test on Well 11 to see if the Chlorides and TDS and Conductivities would decrease with a lower flow. It did not work. We will have to have the Well camera to see if there is a cavity of bad water infiltrating the Well.

The staff changed the prefilters on all four trains. We are constantly cleaning the filters because of a clay like substant is clogging them. We are investigating where the clay is coming from.

Staff changed out the sump pump at the South Tank.

Ehab changed out the UPS at Well 12R.
