WHEREAS, City staff solicited proposals from the City's pre-approved list of Engineers, Architects and Surveyors, to perform visual and structural assessments, as well as compliance with the Americans with Disabilities Act to catalog any deficiencies. After a thorough review of the submissions, Staff recommended engaging The Bentley Group, Inc. to perform the tasks.

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FLAGLER BEACH:
