Before the undersigned officer duly authorized by the State of Florida to administer oaths this day personally appeared Sergeant J. Bingham #7058, who deposes and says:

- 1. That I am over the age of eighteen and a sworn police officer employed by the City of Flagler Beach.
- 2. On 6-29-2024 at approximately 9:22 a.m., I observed a red golf cart with city decal #359, 2024, parked on 3rd Street South near South Central Avenue Flagler Beach, Flagler County, Fl. 32136.
 - 3. I ascertained that the vehicle was registered to Michael Hans of Flagler Beach.
 - 4. The vehicle was parked in violation of 19-23 Parking in the wrong direction.
- 5. Specifically, the Golf Cart was parked on the city right-of-way, facing southwest (angled) in the grass on the south side of the road. It was parked on a section of 3rd Street South that does not have legal access to golf carts.
- 6. During my investigation, I took a still photograph of the vehicle. This photograph is attached to this affidavit. The photograph is a fair and accurate representation of the vehicle and the manner it was parked at the time of my investigation.
- 7. Due to my observation of a vehicle parked in violation of the relevant code section, I issued city citation # P01037FB.




