A RESOLUTION BY THE CITY COMMISSION OF THE CITY OF FLAGLER BEACH TO AWARD BID NO. FB-24-0111 PROJECT # 238 WASTEWATER SLUDGE MANAGEMENT IMPROVEMENTS TO MCMAHAN CONSTRUCTION CO., INC. IN AN AMOUNT NOT TO EXCEED \$2,992,000; PROVIDING FOR CONFLICT AND AN EFFECTIVE DATE.

WHEREAS, the City owns, operates, and maintains a Wastewater Treatment Plant to enhance environmental and public safety. The current facility, located at 2000 Avenue A, Flagler Beach, Florida, is approximately fifty years old and utilizes older, inefficient treatment and disposal systems; and,

WHEREAS, in collaboration with State and regional agencies, the City has designed improvements to the Wastewater Treatment Plant which will increase the facility's capacity and improve the treatment of wastewater; and,

WHEREAS, the State Department of Environmental Protection has provided funding (\$850,000) to support the acquisition and installation of de-watering equipment as part of the wastewater treatment process; and,

WHEREAS, the City acquired the de-watering equipment in September, 2024, and subsequently solicited proposals for the construction of a facility to house and operate the de-watering equipment; and,

WHEREAS, the City, after receiving four proposals, opened those proposals on December 6, 2024 (see Exhibit A); and,

WHEREAS, City staff reviewed the proposals and offered an appropriate recommendation to the City Commission;

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FLAGLER BEACH, AS FOLLOWS:

<u>SECTION 1</u>. The City of Flagler Beach City Commission awards Bid No FB-24-0111 (Wastewater Sludge Management Improvements) to McMahan Construction Co., in an amount not to exceed \$2,992,000.

<u>SECTION 2</u>. The City Commission directs the City Manager to ensure that all necessary reporting related to Departmental of Environmental Protection is completed in a complete and timely manner.

SECTION 3. All resolutions or parts of resolutions in conflict herewith are hereby repealed.

<u>SECTION 4.</u> This Resolution shall become effective immediately upon passage as provided by law. PASSED AND ADOPTED THIS 13th DAY OF FEBRUARY, 2025.
