A RESOLUTION BY THE CITY COMMISSION OF THE CITY OF FLAGLER BEACH, FLORIDA, TO AWARD A CONTRACT TO ENGLAND-THIMS & MILLER, INC. IN AN AMOUNT NOT TO EXCEED \$826,586.66 TO BE THE CONSTRUCTION MANAGER ADVISER (CMA) AND SERVE AS THE CITY'S ON-SITE REPRESENTATIVE OVERSEEING THE CONSTRUCTION OF THE FLAGLER BEACH PIER, PROVIDING FOR CONFLICT AND AN EFFECTIVE DATE.

WHEREAS, the City's nearly one-hundred-year-old Pier has been damaged sufficiently enough to require its closure; and,

WHEREAS, the City contracted with Moffatt & Nichol to assist the City with design and permitting for the demolition of the existing Pier and reconstruction of a new Pier;

WHEREAS, the City awarded the contract for the demolition and reconstruction to Vecillio & Grogan; and,

WHEREAS, the required oversight necessary to ensure appropriate management is beyond the capacity of City staff; and,

WHEREAS, the City solicited qualifications from interested Construction Manager Advisors, receiving, reviewing, and scoring the three submissions received;

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FLAGLER BEACH, AS FOLLOWS:

<u>SECTION 1</u>. The City Commission authorizes City staff to issue the Notice to Proceed to England, Thims & Miller to be the City's on-site Construction Manager Advisor overseeing the Contractor awarded the demolition and reconstruction of the pier in an amount not to exceed \$862,586.66.

<u>SECTION 2</u>. All resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed.

SECTION 3. This Resolution shall become effective immediately upon passage as provided by law.
