

RESOLUTION NO. 11412

A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AMENDMENT TO THE AGREEMENT WITH WESTERN TRUCK PARTS AND EQUIPMENT COMPANY, LLC (CONTRACT NO. 046-21 23-002) FOR THE PURCHASE OF TWO ELECTRIC REFUSE COLLECTION VEHICLES TO UPDATE THE SPECIFICATIONS AND MODIFY THE DELIVERY SCHEDULE

WHEREAS, the Folsom 2035 General Plan commits to reducing the consumption of carbon-intensive fuels through the purchase of more efficient vehicles; and

WHEREAS, the city is currently subject to California's Advanced Clean Fleet Regulations which require fifty percent of all medium and heavy-duty vehicle purchases to be zero-emission by 2024, and 100% of medium and heavy-duty vehicle purchases to be zero-emission vehicles by 2027; and

WHEREAS, refuse collection vehicles consume more diesel fuel than any other City of Folsom fleet vehicles; and

WHEREAS, on August 23, 2022, the Folsom City Council approved Resolution No. 10909 authorizing the purchase of one electric side loader refuse collection vehicle and one electric rear loader refuse collection vehicle to pilot the feasibility of electric vehicle technology within the waste collection operation; and

WHEREAS, the Waste and Recycling Division has contracted with Western Truck Parks and Equipment Company, LLC (WTP) to supply electric refuse collection vehicles; and

WHEREAS, WTP is an approved dealer for California's Hybrid and Zero-Emission Truck and Bus Voucher Incentive Project (HVIP); and

WHEREAS, WTP will use HVIP funding vouchers in the amount of \$240,000 to discount the City of Folsom electric refuse truck purchase; and

WHEREAS, staff has been awarded reimbursement grant funding of \$302,361 from the Sacramento Metropolitan Air Quality Management District (SMAQMD); and

WHEREAS, SMAQMD has notified staff that they may not be able to honor up to \$200,000 of the previous award due to federal funding instability; and

WHEREAS, if the SMAQMD funding is not honored, the Solid Waste Fund (Fund 540) would be used for up to \$200,000 to cover the shortfall; and

WHEREAS, WTP did not deliver fully operational vehicles in the timeframe specified in the contract; and

WHEREAS, WTP has acknowledged mechanical deficiencies with the original vehicle specifications; and

WHEREAS, WTP has proposed upgrades to the vehicles based on revised specifications to correct mechanical deficiencies; and

WHEREAS, WTP has provided a timeline to deliver vehicles meeting the updated specifications; and

WHEREAS, funds in the amount of \$1,112,661 are encumbered in the Solid Waste Fund (Fund 540); and

WHEREAS, the agreement will be in a form acceptable to the City Attorney:

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Folsom hereby authorizes the City Manager to Execute a Contract Amendment to the Agreement with Western Truck Parts and Equipment Company, LLC (Contract No. 046-21 23-002) for the Purchase of Two Electric Refuse Collection Vehicles to Update the Specifications and Modify the Delivery Schedule.
