

**RESOLUTION NO. 11440**

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT A CANNABIS TAX FUND GRANT PROGRAM OFFERED BY THE CALIFORNIA HIGHWAY PATROL, IN THE AMOUNT OF \$248,391.30 TO REDUCE AND MITIGATE THE IMPACTS OF IMPAIRED DRIVING, PROVIDE DUI ENFORCEMENT AND TRAINING, POLICE VEHICLES AND APPROPRIATION OF FUNDS IN THE GENERAL FUND (FUND 010)**

**WHEREAS**, the City of Folsom Police Department is requesting the City Council authorize the acceptance of a grant titled “FY25/26 CTFGP Law Enforcement - Folsom Police Department” for the Period of July 1, 2025, through June 30, 2026, from the State of California, Department of California Highway Patrol, in the amount of \$248,391.30; and,

**WHEREAS**, selective enforcement of the primary causes of collisions are an effective way to deter motorists would speed, drive while under the influence of alcohol and other drugs, including cannabis and cannabis products, or otherwise drive unsafe, thereby reducing fatal and injury collisions; and,

**WHEREAS**, the grant monies will be used to reimburse personnel overtime costs associated with selective traffic enforcement and the training of officers in the detection, apprehension and prosecution of impaired drivers; and,

**WHEREAS**, the grant monies will be used to conduct community outreach programs through school presentations and “Know Your Limits” campaigns; and,

**WHEREAS**, the grant monies will be used to purchase four Fox Fury Nomad 360 LED portable light towers to be deployed at DUI checkpoints and for scene lighting; and,

**WHEREAS**, the grant monies will be used to purchase two BMW police motorcycles and a Ford F250 police truck including communication radios and associated emergency equipment.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Folsom hereby authorizes the acceptance of a grant titled “FY25/26 CTFGP Law Enforcement - Folsom Police Department” from the State of California, Department of Highway Patrol, which will provide funding to conduct selective traffic enforcement geared at reducing the number of fatal and injury collisions in the City and provide funding for three traffic enforcement vehicles. The City Manager or his designee is hereby authorized and empowered to accept and execute in the name of the City of Folsom all necessary contracts, agreements, amendments, and payment requests hereto for the purposes of accepting and fulfilling the requirements of the grant titled “FY25/26 CTFGP Law Enforcement - Folsom Police Department.”; and

**BE IT FURTHER RESOLVED** that the City Council of the City of Folsom authorizes the Finance Director to increase revenue estimates and expenditure appropriations by the grant amount of \$248,391.30 in the General Fund (Fund 010) to be reimbursed by the State of California, Department of the California Highway Patrol.
