SUBJECT:	Resolution No. 11523 - A Resolution Authorizing the City Manager to execute an agreement with Long Beach BMW for the purchase of two police motorcycles in the amount of \$84,000 funded by the CHP Cannabis Tax Fund Grant (Resolution No. 11440) in the General Grants Fund (Fund 012) and \$199.32 from the Police Capital Vehicle Fund (Fund 607)

RECOMMENDATION / CITY COUNCIL ACTION

Staff recommends that the City Council pass and adopt Resolution No. 11523 – A Resolution Authorizing the City Manager to execute an agreement with Long Beach BMW for the purchase of two police motorcycles in the amount of \$84,000 funded by the CHP Cannabis Tax Fund Grant (Resolution No. 11440) in the General Grants Fund (Fund 012) and \$199.32 funded from the Police Capital Vehicle Fund (Fund 607).

BACKGROUND / ISSUE

On August 26, 2025, the City Council passed and adopted Resolution No. 11440, a resolution authorizing the City Manager to accept a Cannabis Tax Fund Grant Program offered by the California Highway Patrol, in the amount of \$248,391.30 to reduce and mitigate the impacts of impaired driving, provide DUI enforcement and training, police vehicles and appropriation of funds.

POLICY / RULE

Section 2.36.080 of the Folsom Municipal Code requires that the City Council award contracts above \$75,049.

ANALYSIS

In June 2025, the Police Department was awarded a Cannabis Tax Fund Grant Program from the State of California, Department of the California Highway Patrol in the amount of \$248,391.30. The police department agreed to purchase two BMW police motorcycles under the terms of the grant.

FINANCIAL IMPACT

This grant award increased revenue estimates and appropriations by \$248,391.30 in the General Grants Fund (Fund 012). Costs are funded initially through the General Grants Fund (Fund 012) and reimbursed by the State of California, Department of California Highway Patrol.

Staff recommends that the City Council authorize the City Manager to execute an agreement with Long Beach BMW for the purchase of two police motorcycles for a total amount of \$84,199.32

Sufficient funds are budgeted and available in the General Grants Fund (Fund 012) and the Police Capital Vehicle Fund (Fund 607) to support the motorcycle purchase, in the amounts of \$84,000 and \$199.32 respectively, for a total purchase cost of \$84,199.32.
